MOTION TO INTERVENE

Pursuant to *Conn. Gen. Stat.* § 4-177a(b) and RCSA § 16-50j-15(a), the Town of Woodbridge (the “Town”) respectfully requests intervenor status in the above-captioned action. The Town states as follows:

1. The Town is a municipal corporation organized under the laws of the State of Connecticut.
2. The Town requests that the following attorneys be placed on the Service List in this proceeding as counsel for the Town:

3. The Town’s participation is in the interests of justice because the Town and its residents will be directly impacted if the Siting Council (“Council”) approves the pending Petition. In particular, approval of the Petition may result in significant negative impact to the use and enjoyment of nearby residential properties, reduction of property values, decrease in Town tax revenue, and uncertainty in future infrastructure changes to the project area that may further impact the Town and its residents overall. Namely, how the proposed solar array impacts the unconstructed 100-foot cell tower approved by the Council in 2021

(Docket No. 502) at one of the seven parcels that together comprise the new solar project area.

4. The Town's participation will not impair the orderly conduct of the proceedings.
5. The Town's participation will furnish assistance to the Council in resolving the issues of this case because the Town can provide the unique perspective of a municipality whose residents will be directly impacted, should the Council approve the proposed Petition. Approval of the Petition would exempt the applicant from the more robust standards of review applicable to the Council's consideration of Certificates of Environmental Compatibility and Public Need, which the Town believes is necessary due to the sensitive environmental nature of the residential community surrounding the project area and the substantial landscape clearing and construction required for this project.
6. The Town is seeking the right to participate in this proceeding by filing interrogatories, receiving data and information filed by parties and other intervenors, cross-examining witnesses, filing briefs, and/or presenting oral argument concerning any and all issues that may be presented in this matter.

WHEREFORE, the Town of Woodbridge requests to be designated as an intervenor in this proceeding.

Dear Ms. Bachman:

I am writing to offer public comment on the above Petition on behalf of my client, the Town of Woodbridge. Given the sensitivity of the project area and the potential impact on the Town and its residents, the Town has concurrently filed a Motion to Intervene, seeking intervenor status, to continue necessary participation and input during these proceedings.

The Town has real concerns about the negative impact of the project if approved by the Council. Approval of the sizable proposed solar array, spanning seven separate parcels, may result in significant negative impact to the use and enjoyment of nearby residential properties, reduction of property values, decrease in Town tax revenue, and uncertainty in future infrastructure changes to the project area that may further impact the Town and its residents overall. Namely, how the proposed solar array affects the unconstructed 100-foot cell tower approved by the Council in 2021 (Docket No. 502) at one of the seven parcels that together comprise the new solar project area.

Approval of the Petition would exempt the applicant from the more robust standards of review applicable to the Council's consideration of Certificates of Environmental Compatibility and Public Need, which the Town believes is necessary due to the sensitive environmental nature of the residential community surrounding the project area and the substantial landscape clearing and construction required for this project.

For these reasons, the Town submits its concerns to the public record and seeks ongoing participation in these proceedings.
