Pursuant to the provisions of the Regulations of Connecticut State Agencies, Section 16-50j-40(a), this letter serves as notice that CEFIA Holdings, LLC d/b/a Verogy ("Verogy") intends to file a Petition for Declaratory Ruling ("Petition") with the Connecticut Siting Council ("Council") on or about November 18, 2025 seeking approval for the construction, operation, and maintenance, of a 1.7 megawatt ("MW") alternating current ("AC") canopy-mounted solar photovoltaic electric generating facility, including all its associated equipment, ("Project") at the CT DOT Headquarters, located at 2710-2800 Berlin Turnpike, Newington, Connecticut ("Project Site").

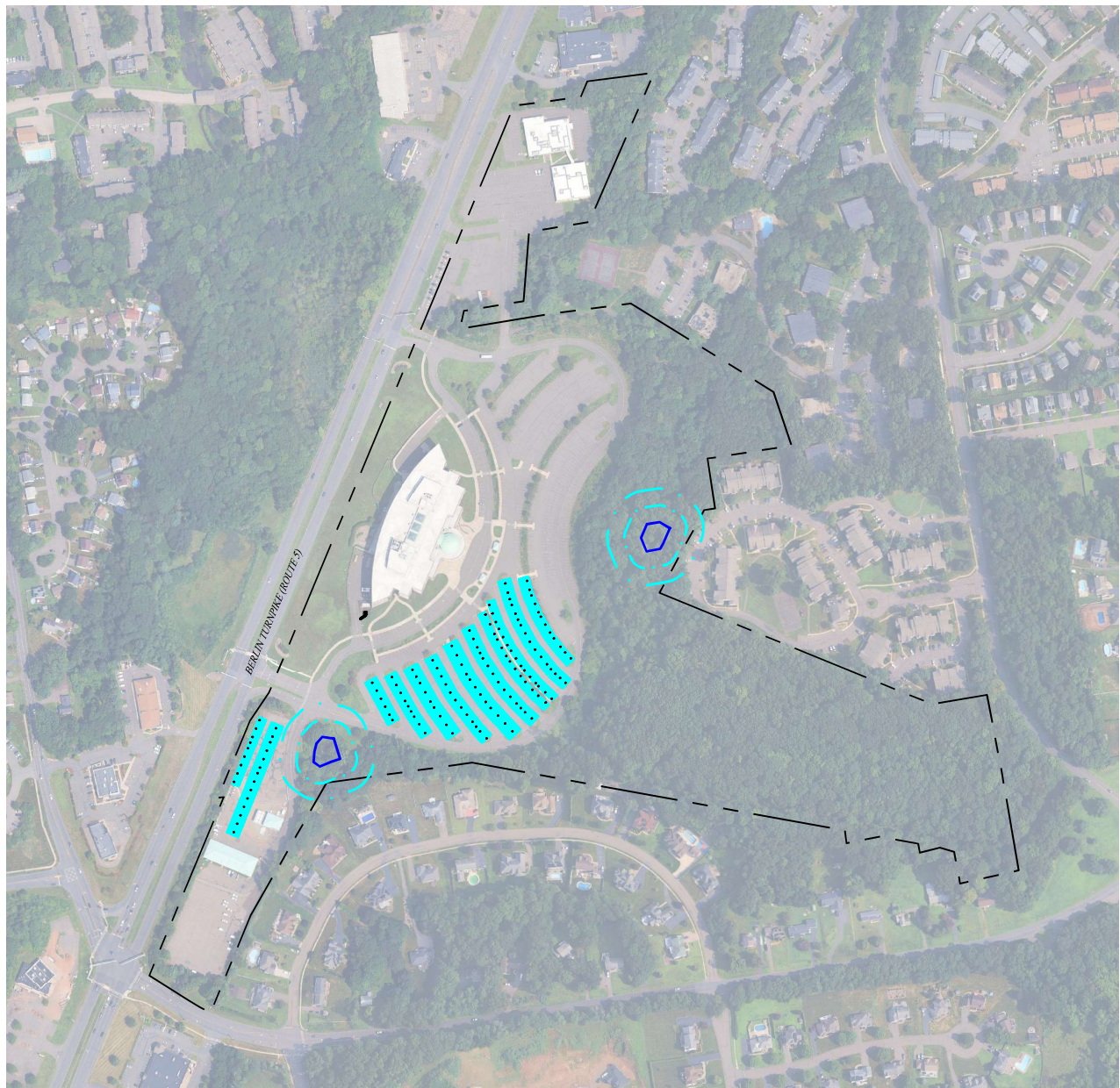
The proposed Project will consist of the installation of solar modules on a canopy racking structure, anchored to the ground using pile driven posts within the existing paved parking areas. An equipment pad located adjacent to the existing building and fuel tank area will contain the projects meters and disconnects. The Project's inverters and combiner panels will be mounted to the canopy structure. The Project will be accessed through the existing driveway serving the building and all associated parking areas and interconnected to the facility's existing electrical room. A Proposed Conditions Figure is attached to this letter for your review

Pursuant to the provisions of the Connecticut General Statutes Section 16-50g and the following sections, the location of certain Project features may change as this Petition proceeds through the Council's regulatory review process. Once filed, a full copy of the Petition will be placed on file at the Newington Town Hall for your review. 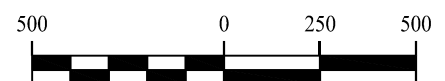
