Subject: Shepaug Solar Project

Shepaug LLC, a co-development of FirstLight Generation LLC (“FirstLight”) and Davis Hill Development LLC (DHD), is writing to inform and provide you with notice of an upcoming submission to the Connecticut Siting Council (“CSC”) of our proposed 1.99 megawatt Solar Project (“Shepaug Solar Project”) located adjacent to FirstLight’s Shepaug Hydroelectric Generation Station at 2225 River Road in Southbury CT.

About the Project

The Shepaug Solar Project will increase FirstLight’s ability to provide more renewable energy to the State of Connecticut and its residents through Eversource’s Shared Clean Energy Facility (“SCEF”) program. The Shepaug Solar Project will be located northeast of the existing Shepaug Hydroelectric Generation Station and west of Eversource’s transmission lines, which cross FirstLight’s property. The Shepaug Solar Project will not be visible from the existing Bald Eagle Observatory at the Shepaug Station, or the reservoirs of Lake Zoar or Lake Lillinonah. This Project and others like it are critical to meeting Connecticut’s goal of a 100% zero-carbon electric supply by 2040.

The Shepaug Solar Project will connect into the local electrical distribution grid using a combination of existing infrastructure and new wires. The Shepaug Solar Project will cover an area of 11.78 acres and consist of 3,770 solar panels, 15 inverters, a pad-transformer and switchgear. The entire site will be enclosed by a security fence with access through the existing entrance road to the Shepaug Hydrogeneration Station.

FirstLight will ensure that construction occurs outside the Bald Eagle’s winter migratory season, and has connected with Connecticut DEEP to confirm the Shepaug Solar Project will not impact nesting in the area. Agrivoltaics features are also incorporated in the project design, including establishing a native pollinator meadow below the solar panels and adding a honeybee apiary to the property to support local biodiversity, improve long-term soil health, and enhance existing pollinator meadows at the site.

Project Timeline

We anticipate that the petition for the Shepaug Solar Project will be filed with the CSC in the near future, with an anticipated approval in Spring 2026. Pending receipt of all necessary approvals and equipment procurement, our goal is to begin preliminary site work in Spring/Summer of 2026, with construction finishing during the Fall of 2026.
