It was a pleasure to meet with you on 3/17/26 regarding your proposed project. Please help us improve our pre-application process by completing [this quick follow-up survey](#) – thank you

Verogy is proposing the construction of a +/- 1.9 MW AC ground mounted solar array located at 122 Mill Road & 208 Rimmon Road in North Haven-project is located on two parcels; western parcel is mostly prime farmland and eastern is not.

In addition to the array, the project proposes the construction of associated equipment & infrastructure such as three permanent partially above grade stormwater detention basins that will store less than three acre feet in volume. Currently, the site is agricultural land and after construction will be covered with meadowy grassy vegetation.

The project is in a NDDDB Area and is projected to be submitted to the CT Siting Council in April of 2026.

CT State Historic Preservation Office (SHPO) Phase 1 surveys are currently being conducted, and test pitting will be done latter this year. A NDDDB determination was already received for this project.

Anticipated project land disturbance is approximately 10 acres. Very little tree clearing is anticipated.

Based upon the information presented at the meeting, a summary of the permitting requirements is as follows:

Stormwater Program: your contacts are Chris Stone & Brian Dinh

The applicant needs to [submit a registration](#) under DEEP's [Stormwater Construction General Permit](#) as a locally exempt project at least 60 days before beginning construction.

General Notes

- Please document the location of the water quality test pits on at least one page of the plans when submitting.
- Please be mindful of tree clearing and Time of Year Restrictions in relation to the Long Ear Bat being potentially being present on site.

Office of Environmental Review & Strategic Initiatives (ERSI): your contacts are Linda Brunza, Laschone Garrison, & Jordan DiDomenico

There are no comments but please be aware that there may be requirements from the Department of Agriculture when submitting to CT Siting Council.

As discussed, ERSI regularly conducts site visits for solar projects and will reach out in the future, via email, to set one up. ERSI provides the CT Siting Council with comments concerning solar projects.

Dam Safety Program: your contacts are Kyle Zukauskas & Daniel Lesniewski

To determine if Dam Safety permitting may be required for the proposed project, a hazard classification must be assigned. The hazard classification is based on what is located downstream and could be affected in the event of a breach (e.g., residences, commercial areas, driveways, other basins, public utilities, etc.). Please submit a plan showing the approximate location and storage of each of the detention basins. If the basins receive a Hazard Classification of AA, no Dam Safety permits will be required. Once the basins have been constructed, they will then need to be registered with Dam Safety.

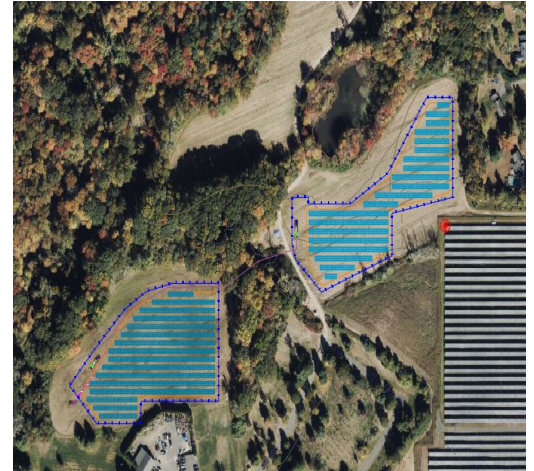
North Haven Solar Two

PROJECT DESCRIPTION

- North Haven Solar Two is a solar project located at 700 Middletown Avenue, 122 Mill Road, and 208 Rimmon Road in North Haven, Connecticut.
- The 1.9 MW AC system will generate enough electricity to power 337 average homes for a year.
- The project site is designed to have minimal environmental impacts with no disruption to wetlands or core forest.

BENEFITS TO NORTH HAVEN

- Increased new annual municipal tax revenues with no additional burden on city services.
- Infrastructure upgrades that improve the reliability of North Haven's electrical grid.
- Reduction in energy demand during peak usage will decrease energy costs for ratepayers statewide.
- Strengthened renewable energy resources that produce electricity locally with zero pollution.



ACHIEVING THE 100% ZERO CARBON TARGET BY 2040 & ENVIRONMENTAL BENEFITS

- As a Class I Renewable Energy Source, North Haven Solar Two will help support the goals set forth in Governor Lamont's September 2019 Executive Order No. 3 100% zero carbon target for the electricity sector by 2040.

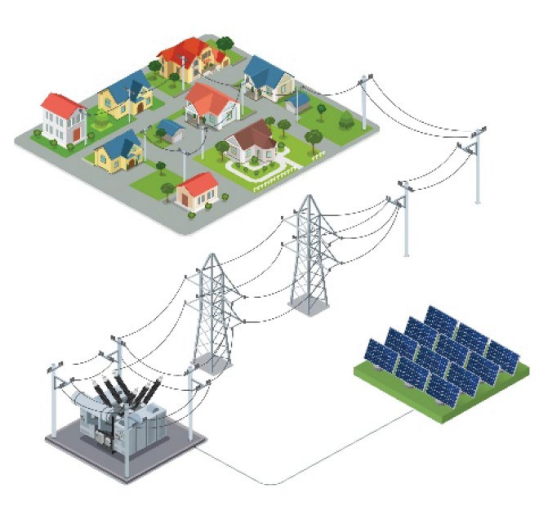
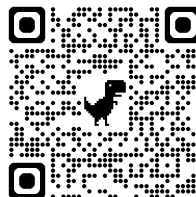

Pursuant to the provisions of the Regulations of Connecticut State Agencies, Section 16-50j-40(a), this letter serves as notice that VCP, LLC d/b/a Verogy, LLC and North Haven Solar Two, LLC intends to file a Petition for Declaratory Ruling (“Petition”) with the Connecticut Siting Council (“Council”) on or about May 21, 2026 seeking approval for the construction, operation, and maintenance, of a 1.9 megawatt (“MW”) alternating current (“AC”) ground-mounted solar photovoltaic electric generating facility (“Project”) located across portions of three parcels identified as 700 Middletown Avenue, 208 Rimmon Road and 122 Mill Road, in North Haven, Connecticut (the “Property”).

The Project will consist of the installation of solar modules on steel racking, inverters, transformers, and switch gear on an eight-acre portion of the Property. Access to the Project area will extend from the cemetery property at 700 Middletown Avenue, over an existing paved driveway. A Proposed Project Layout Map is attached to this letter.

Pursuant to the provisions of the Connecticut General Statutes Section 16-50g et. seq the location of certain Project features may change as this Petition proceeds through the Council’s regulatory review process. Once filed, a full copy of the Petition will be available for review at the North Haven Town Hall. In addition, an electronic copy of the Petition will be available on the Council’s website at www.ct.gov/csc/ under the Pending Matters tab.
