interconnection.

#### I. Introduction

The application is from Gravel Pit Solar for the construction, maintenance, and operation of a 120 MW solar facility in the Town of East Windsor. The Town of South Windsor is within 2,500 feet of the proposed facility.

## II. Technical

The application conforms to the Council's *Application Guide for a Renewable Energy Facility* dated April 2010, includes relevant maps, descriptions of the proposed facility, costs, a description of the environmental effects of the proposed construction, and health and safety information. The application meets statutory technical requirements for processing the application. This project would not require an outside consultant.

### III. Administrative Review

All service and filing requirements pursuant to Connecticut General Statutes (CGS) § 16-50*l* (b) have been fulfilled. Notice to the general public was published in the *Hartford Courant* on September 4, 2020.

#### IV. Procedural

Pursuant to CGS §16-50m, the Council must schedule a public hearing not less than 30 days and no more than 150 days after receipt of an application. At least one public hearing session shall be held after 6:30 PM for the convenience of the general public. The Council must also designate a place for the deposition of the transcript. In accordance with CGS §16-50m and Governor Lamont's March 14, 2020 Executive Order No. 7B, staff recommends holding a remote public hearing via Zoom conferencing on November 12, 2020, and depositing the transcript in the East Windsor and South Windsor Town Halls.
