#### 1. Minutes of September 23, 2021.

Mr. Silvestri moved to approve the Minutes of September 23, 2021; seconded by Mr. Edelson. The motion passed unanimously.

#### 2. FORECAST-2021/2022 - Connecticut Siting Council 2020 Review of the Ten-Year Forecast of Connecticut Electric Loads and Resources. Public Comment Session Schedule.

Mr. Silvestri moved to approve the Public Comment Session Schedule as per staff recommendations; seconded by Mr. Edelson. The motion passed unanimously.

3. **PETITION NO. 1406A – Doosan Fuel Cell America, Inc. petition for a declaratory ruling, pursuant to Connecticut General Statutes §4-176 and §16-50k, for the proposed construction, maintenance and operation of a grid-side 9.66-megawatt fuel cell facility and associated equipment to be located at 600 Iranistan Avenue, Bridgeport, Connecticut, and associated electrical interconnection to the United Illuminating Company's existing Congress Street Substation. NuPower Bridgeport FC, LLC Reopening of this petition based on changed conditions pursuant to Connecticut General Statutes §4-181a(b). Allco Motion to Change the Procedural Schedule to Allow for Additional Discovery. Allco Motion to Stay Proceedings until an Environmental Impact Evaluation is Prepared. Decision.**

Mr. Edelson moved to deny Allco's Motion to Change the Procedural Schedule to Allow for Additional Discovery and Allco's Motion to Stay Proceedings until an Environmental Impact Evaluation is Prepared; seconded by Mr. Silvestri. The motion passed with Mr. Nguyen abstaining.

Mr. Edelson moved to approve this petition with the conditions noted in the staff report; seconded by Mr. Lynch. After discussion, Mr. Edelson withdrew his motion and Mr. Lynch withdrew his second.

Mr. Silvestri moved to approve the petition with the conditions noted in the staff report and the additional condition that one foot of fill be added for flood protection; seconded by Mr. Lynch. The motion passed with Mr. Nguyen abstaining.

4. **PETITION NO. 1459 - The Connecticut Light and Power Company d/b/a Eversource Energy petition for a declaratory ruling, pursuant to Connecticut General Statutes §4-176 and §16-50k, for the proposed modifications to its existing Shunock Substation located at 25 Pendleton Hill Road, North Stonington, Connecticut and related electric transmission line structure improvements. Decision.**

Mr. Silvestri moved to approve this petition with the conditions noted in the staff report; seconded by Mr. Edelson. The motion passed unanimously.

5. **PETITION NO. 1460 – Greenskies Clean Energy, LLC petition for a declaratory ruling, pursuant to Connecticut General Statutes §4-176 and §16-50k, for the proposed construction, maintenance and operation of a 4.0-megawatt AC solar photovoltaic electric generating facility located east of the Cornwall town boundary at 129 Bartholomew Hill Road, Goshen, Connecticut and associated electrical interconnection. CGS §4-176 Deadline for Action - Set Date for Decision.**

Mr. Edelson moved to set the date by which to render a decision in accordance with Connecticut General Statutes § 4-176(e) and Section 16-50j-40(c) of the Regulations of Connecticut State Agencies, as no later than February 9, 2022; seconded by Mr. Nguyen. The motion passed unanimously.

6. **PETITION NO. 1461 – SBA Communications Corporation petition for a declaratory ruling, pursuant to Connecticut General Statutes §4-176 and §16-50k, for the proposed**

**replacement and extension of an existing telecommunications facility located at 130 Welles Road, Groton, Connecticut. CGS §4-176 Deadline for Action - Set Date for Decision.**

Mr. Edelson moved to set the date by which to render a decision in accordance with Connecticut General Statutes § 4-176(e) and Section 16-50j-40(c) of the Regulations of Connecticut State Agencies, as no later than February 14, 2022; seconded by Mr. Silvestri. The motion passed unanimously.

7. **PETITION NO. 1462 – Distributed Solar Operations, LLC and IKEA Property, Inc. notice of election to waive exclusion from Connecticut Siting Council jurisdiction, pursuant to Connecticut General Statutes §16-50k(e), and petition for a declaratory ruling, pursuant to Connecticut General Statutes §4-176 and §16-50k, for the proposed construction, maintenance and operation of a 0.90-megawatt AC solar photovoltaic electric generating facility located at IKEA, 450 Sargent Drive, New Haven, Connecticut, and associated electrical interconnection. CGS §4-176 Deadline for Action - Set Date for Decision.**

Mr. Edelson moved to set the date by which to render a decision in accordance with Connecticut General Statutes § 4-176(e) and Section 16-50j-40(c) of the Regulations of Connecticut State Agencies, as no later than February 16, 2022; seconded by Mr. Lynch. The motion passed unanimously.
