1. Minutes of January 13, 2022.

Mr. Silvestri moved to approve the Minutes of January 13, 2022; seconded by Mr. Lynch. The motion passed unanimously.

2. **DOCKET NO. 500 - Arx Wireless Infrastructure, LLC Certificate of Environmental Compatibility and Public Need for the construction, maintenance, and operation of a telecommunications facility located at 1061-1063 Boston Post Road, Milford, Connecticut. Development and Management Plan.**

Mr. Silvestri moved to approve the Development and Management Plan with the condition noted in the staff report and the additional condition to provide complete contact information/procedures to notify state and local agencies within the fuel spill prevention plan; seconded by Ms. Cooley. The motion passed with Mr. Quinlan and Mr. Morissette abstaining.

3. **PETITION NO. 1468 – The Connecticut Light and Power Company d/b/a Eversource Energy petition for a declaratory ruling, pursuant to Connecticut General Statutes §4-176 and §16-50k, for the proposed Montville to Horton Cove Rebuild Project consisting of the replacement and reconductoring of electric transmission line structures along approximately 0.6 mile of its existing Nos. 100 69-kilovolt (kV) and No. 1410 115-kV electric transmission lines within existing Eversource electric transmission line right-of-way between Horton Cove and Montville Substation in Montville, Connecticut, and related electric transmission line and substation improvements. Decision.**

Ms. Cooley moved to approve this petition with the condition noted in the staff report and a recommendation that Eversource work with the Town to develop and implement traffic management procedures, as needed; seconded by Mr. Quinlan. The motion passed unanimously.

4. **PETITION NO. 1469 – LSE Indus, LLC petition for a declaratory ruling, pursuant to Connecticut General Statutes §4-176 and §16-50k, for the proposed construction, maintenance and operation of a 1.99-megawatt AC solar photovoltaic electric generating facility located at 81 East Main Street, North Canaan, Connecticut and associated electrical interconnection. Decision.**

Mr. Silvestri moved to approve this petition with the conditions noted in the staff report, and the additional condition to provide complete contact information/procedures to notify state and local agencies within the fuel spill prevention plan; seconded by Mr. Quinlan. The motion passed unanimously.

5. **PETITION NO. 1472 – Dynamic Energy Solutions, LLC as agent for Stag Industrial Holdings, LLC petition for a declaratory ruling, pursuant to Connecticut General Statutes §4-176 and §16-50k, for the proposed construction, maintenance and operation of a 1.5 megawatt AC solar photovoltaic electric generating facility located at 40 Pepes Farm Road, Milford, Connecticut, and associated electrical interconnection. Decision.**

Mr. Silvestri moved to approve this petition with the conditions noted in the staff report, and the additional condition that Dynamic Energy Solutions, LLC meet with local first responders and provide training prior to the commencement of site operation; seconded by Mr. Quinlan.
