1. Minutes of June 23, 2022.

Mr. Silvestri moved to approve the Minutes of June 23, 2022; seconded by Mr. Lynch. The motion passed unanimously.

2. **DOCKET NO. 508 – The United Illuminating Company (UI) application for a Certificate of Environmental Compatibility and Public Need for the Milvon to West River Railroad Transmission Line 115-kV Rebuild Project that consists of the relocation and rebuild of its existing 115- kilovolt (kV) electric transmission lines from the railroad catenary structures to new steel monopole structures and related modifications to facilitate interconnection of the rebuilt 115-kV electric transmission lines at UI’s existing Milvon, Woodmont, Allings Crossing, Elmwest and West River substations along approximately 9.5 miles of the Connecticut Department of Transportation’s Metro-North Railroad corridor traversing the municipalities of Milford, Orange, West Haven and New Haven, Connecticut. Close of Evidentiary Record.**

Mr. Silvestri moved to approve the close of the evidentiary record; seconded by Mr. Quinlan. The motion passed unanimously.

3. **DOCKET NO. 510 – New Cingular Wireless PCS, LLC d/b/a AT&T and Tarpon Towers II, LLC application for a Certificate of Environmental Compatibility and Public Need for the construction, maintenance, and operation of a telecommunications facility located at 92 Greens Farms Road, Westport, Connecticut. Request for Party/Intervenor Status.**

Mr. Lynch moved to grant Party Status to the Town of Westport; seconded by Mr. Collette. The motion passed unanimously.

4. **PETITION NO. 1507 – VCP EPC, LLC d/b/a Verogy petition for a declaratory ruling, pursuant to Connecticut General Statutes §4-176 and §16-50k, for the proposed construction, maintenance and operation of a 2.99-megawatt AC solar photovoltaic electric generating facility located at Dollar Tree Distribution Center, 99 International Drive, Windsor, Connecticut, and associated electrical interconnection. Decision.**

Mr. Silvestri moved to approve this petition with the conditions noted in the staff report; seconded by Mr. Nguyen. The motion passed unanimously.

Mr. Lynch moved to approve this petition with the conditions noted in the staff report; seconded by Mr. Quinlan. The motion passed unanimously.
