Meeting of July 21, 2022

1. Minutes of July 7, 2022.

Mr. Silvestri moved to approve the Minutes of July 7, 2022; seconded by Mr. Lynch. The motion passed with Mrs. Cooley abstaining.

2. **DOCKET NO. 510 – New Cingular Wireless PCS, LLC d/b/a AT&T and Tarpon Towers II, LLC application for a Certificate of Environmental Compatibility and Public Need for the construction, maintenance, and operation of a telecommunications facility located at 92 Greens Farms Road, Westport, Connecticut. Request for Party/Intervenor Status**

Mr. Collette moved to grant Intervenor status to Donald Bergmann, limiting participation under CGS §4-177a(d) to the specific statutory evaluation criteria for the application under the Public Utility Environmental Standards Act, and striking Items (ii) and (iv) from the June 30, 2022 Request for Intervenor Status and Items (2) and (8) from the June 22, 2022 Pre-Filed Testimony, as those items relate to prohibited ex parte communications and matters irrelevant to the Council's review of the application; seconded by Mr. Silvestri. The motion passed unanimously.

3. **PETITION NO. 1508 – Enfield Solar One, LLC and VCP, LLC d/b/a Verogy petition for a declaratory ruling, pursuant to Connecticut General Statutes §4-176 and §16-50k, for the proposed construction, maintenance and operation of a 4.0-megawatt AC solar photovoltaic electric generating facility located at 110 North Street, Enfield, Connecticut, and associated electrical interconnection. Decision.**

Mrs. Cooley moved to approve this petition with the conditions noted in the staff report and the additional conditions that the petitioner submit the Phase 1B cultural resource survey and the associated SHPO response, if any; provide contact information for the spill response contractor; and install landscape screening at the northwest corner of the facility along the fence line; and with the recommendation that the petitioner examine the feasibility of reducing the number of interconnection utility poles; seconded by Mr. Quinlan. The motion passed with Mr. Lynch recusing.

4. **PETITION NO. 1512 – New Cingular Wireless PCS, LLC (AT&T) petition for a declaratory ruling, pursuant to Connecticut General Statutes §4-176 and §16-50k, for the proposed installation of a small wireless facility on a 37-foot 6-inch state-owned replacement light pole and associated equipment to be located in the southeastern portion of the Manchester Community College campus off Ramey Drive near the Bicentennial Band Shell entrance in Manchester, Connecticut. Decision.**

Mr. Silvestri moved to approve this petition with the conditions noted in the staff report; seconded by Mr. Collette. The motion passed with Mr. Lynch recusing.

5. **PETITION NO. 1518 - Dish Wireless LLC petition for a declaratory ruling, pursuant to Connecticut General Statutes §4-176 and §16-50k, for proposed modifications to an existing telecommunications facility located at 1081 North Street, Greenwich, Connecticut. CGS §4-176 Deadline for Action - Set Date for Decision.**

Mr. Collette moved to set the date by which to render a decision in accordance with Connecticut General Statutes § 4-176(e) and Section 16-50j-40(c) of the Regulations of Connecticut State Agencies, as no later than November 19, 2022; seconded by Mr. Lynch. The motion passed unanimously.

6. **PETITION NO. 1519 - Bloom Energy Corporation petition for a declaratory ruling, pursuant to Connecticut General Statutes §4-176 and §16-50k, for the proposed construction, maintenance and operation of a customer-side 300-kilowatt fuel cell facility and associated equipment to be located at the University of New Haven, 300 Boston Post Road, West Haven, Connecticut. Decision.**

Mr. Silvestri moved to approve this petition with the conditions noted in the staff report; seconded by Mr. Lynch. The motion passed unanimously.

7. **PETITION NO. 1520 - Bloom Energy Corporation petition for a declaratory ruling, pursuant to Connecticut General Statutes §4-176 and §16-50k, for the proposed construction, maintenance and operation of a customer-side 500-kilowatt fuel cell facility and associated equipment to be located at New Milford Hospital, 21 Elm Street, New Milford, Connecticut. CGS §4-176 Deadline for Action - Set Date for Decision.**

Mr. Quinlan moved to set the date by which to render a decision in accordance with Connecticut General Statutes § 4-176(e) and Section 16-50j-40(c) of the Regulations of Connecticut State Agencies, as no later than December 10, 2022; seconded by Mrs. Cooley. The motion passed unanimously.
