associated electrical interconnection. Completeness Review.

I. Introduction

The application is from LSE Serpens, LLC for the construction, maintenance, and operation of a 3.0 MW solar facility in the City of Torrington. The Town of New Hartford is within 2,500 feet of the proposed facility.

II. Technical

The application conforms to the Council's Application Guide for Electric Generating and Energy Storage Facilities, includes relevant maps, descriptions of the proposed facility, costs, a description of the environmental effects of the proposed construction, and health and safety information. The application meets statutory technical requirements for processing the application. This project would not require an outside consultant.

III. Administrative Review

All service and filing requirements pursuant to Connecticut General Statutes (CGS) § 16-50*l* (b) have been fulfilled. Notice to the general public was published in the <u>Republican-American</u>.

IV. Procedural

Pursuant to CGS §16-50m, the Council must schedule a public hearing not less than 30 days and no more than 150 days after receipt of an application. At least one public hearing session shall be held after 6:30 PM for the convenience of the general public. The Council must also designate a place for the deposition of the transcript. Staff recommends holding a public hearing via Zoom remote conferencing on June 5, 2025 and depositing the transcript in the Torrington City Hall.
