Dear Mr. Coppins:

At a public meeting of the Connecticut Siting Council (Council) held on February 6, 2014, the Council approved the transfer of the Certificate of Environmental Compatibility and Public Need (Certificate) from T-Mobile Northeast, LLC to Phoenix Partnership, LLC. This approval of transfer is consistent with State law and conditioned on the consent of Phoenix Partnership, LLC. to comply with all the terms, limitations, and conditions contained in said Certificate issued on February 2, 2012 and on the timely payment of apportioned assessment charges for the facility under Connecticut General Statute § 16-50v(b)(2).

Furthermore, the Council considered Phoenix Partnership, LLC request for an extension of time dated January 22, 2014, and granted an extension of time until February 3, 2015 to complete the construction of this project. Please notify the Council in writing upon completion of construction and site operation.

Pursuant to conditions 7 and 8 of the Certificate, any request for extension to fully construct this telecommunications facility with at least one fully operational wireless telecommunications carrier shall be filed with the Council not later than 60 days prior to the expiration of this Certificate and shall be served on all parties and intervenors, as listed on the current service list and the Town.
