The Connecticut Siting Council (Council) is in receipt of the request for an extension of construction time in this docket dated December 31, 2013. Pursuant to Condition No. 8 of the Certificate dated October 6, 2011, I have considered your request for an extension of construction time in this docket and granted a one-year extension of time until April 8, 2015, to complete the construction of this project.

Pursuant to conditions 8 & 9 of the Certificate, any request for extension to fully construct this telecommunications facility with at least one fully operational wireless telecommunications carrier shall be filed with the Council not later than 60 days prior to the expiration of this Certificate and shall be served on all parties and intervenors, as listed on the current service list and the Town.

This extension is granted with the understanding that the Council will be notified should the applicant decide not to proceed with construction.
