Re: **Docket No. 272** - The Connecticut Light and Power Company and The United Illuminating Company Application for a Certificate of Environmental Compatibility and Public Need for the Construction of a New 345-kV Electric Transmission Line and Associated Facilities Between Scovill Rock Switching Station in Middletown and Norwalk Substation in Norwalk, Connecticut Including the Reconstruction of Portions of Existing 115-kV and 345-kV Electric Transmission Lines, the Construction of the Beseck Switching Station in Wallingford, East Devon Substation in Milford, and Singer Substation in Bridgeport, Modifications at Scovill Rock Switching Station and Norwalk Substation and the Reconfiguration of Certain Interconnections.

Dear Chairman Katz,

In accordance with the Council's December 16, 2004 notice, the Connecticut Light and Power Company and the United Illuminating Company (the "Companies") identify the following topics for the January 5, 2005 "Clean-up Day:"

- Exhibit 171 has not yet been admitted as a full exhibit. This exhibit consists of the Companies' Responses to CSC Interrogatories, Set 5, Questions 91-94, concerning reduction of magnetic fields along the proposed overhead segments (Segments 1 and 2). The Companies will present witnesses (Ms. Bartosewicz, Mr. Prete, and Dr. Bailey) to sponsor these exhibits, and to be available for cross-examination.
- Supplemental mapping of facilities and areas along proposed underground segments (Segments 3 and 4). Conn. Gen. Stat. § 16-50(a)(10) requires that an application for a transmission line be accompanied by a map of suitable scale showing specified facilities and areas in the vicinity of the proposed route. Section 1 of P.A. 04-246 amended that provision by adding items to the list. On July 26, 2004, the Companies supplemented the maps filed with the application to show the entire expanded list of



facilities and areas for the proposed overhead segments (Segments 1 and 2)¹. Those maps have been admitted into evidence as Exhibit 138. On or before December 28, 2004, the Companies will file similar maps providing the required information for the proposed underground segments (Segments 3 and 4). (Conn. Gen. Stat. § 16-50(a)(10) applies to overhead and underground lines alike.) The Companies will provide witnesses (Ms. Bartosewicz and Mr. Prete) to sponsor these additional maps as exhibits; and they will be available for cross-examination.)


