


Figure 1: Cross Section 1 (See Map 1 of Exhibit # 163 for general area)




Figure 2: Cross Section 2 (See Map 1 of Exhibit # 163 for general area)




Figure 3: Cross Section 2 (See Map 2 of Exhibit # 163 for general area)




Figure 4: Cross Section 2 (See Map 2 of Exhibit # 163 for general area)




Figure 5: Cross Section 2 (See Map 2 of Exhibit #163 for general area)




Figure 9: Cross Section 2 (See Map 4 of Exhibit #163 for general area)




Figure 10: Cross Section 2 (See Map 4 of Exhibit #163 for general area)




Figure 12: Cross Section 5 (See Map 4 of Exhibit #163 for general area)




Figure 13: Cross Section 5 (See Map 4 of Exhibit #163 for general area)




Figure 14: Cross Section 5 (See Map 4 of Exhibit #163 for general area)




Figure 16: Cross Section 5 (See Map 5 of Exhibit #163 for general area)




Figure 18: Cross Section 6E (See Map 6 of Exhibit #163 for general area)




Figure 20: Cross Section 7 (See Map 6 of Exhibit #163 for general area)




Figure 21: Cross Section 7B (See Map 6 of Exhibit #163 for general area)




Figure 22: Cross Section 8N (See Map 7 of Exhibit #163 for general area)




Figure 23: Cross Section 8N (See Map 7 of Exhibit #163 for general area)




Figure 24: Cross Section 8M (See Map 9 of Exhibit #163 for general area)




Figure 25: Cross Section 8S (See Map 10 of Exhibit #163 for general area)




Figure 27: Cross Section 8S (See Map 11 of Exhibit #163 for general area)




Figure 29: Cross Section 8S (See Map 11 of Exhibit #163 for general area)




Figure 30: Cross Section 8S (See Map 11 of Exhibit #163 for general area)




Figure 31: Cross Section 8S (See Map 11 of Exhibit #163 for general area)




Figure 36: Cross Section 8S (See Map 12 of Exhibit #163 for general area)
