



Question:

Please clarify the number of 345-kV line termination structures and 115-kV line termination structures. The first paragraph of Project Description section of the D&M plan states that there will be one 345-kV line termination structure and three 115-kV line termination structure but then the paragraph goes on to say that there will be three 110 foot lightning masts (which are associated with the 345-kV termination structures according to the second paragraph) and one 80 foot tall lightning mast (which is associated with the 115-kV termination structure according to the second paragraph).

Response:

There are three 115-kV line termination structures and one 345-kV line termination structure, each with lightning rods on top of these structures. In addition, there are two 110 foot standalone lightning masts to shield the two underground cable terminations located in the north side of the 345-kV switchyard, one 110 foot stand-alone lightning mast to shield the single-phase autotransformers and the area adjacent to the autotransformers, and one 80-foot stand-alone lightning mast to protect the relay and control enclosure adjacent to the 115-kV bus. These additional lightning masts are identified by single dots on Exhibit 3 of the D&M Plan.

Provide all new developments regarding the permitting of the Mill River, Ash Creek, and Sasco Creek crossing.

Response:

The Department of Environmental Protection has noticed a hearing schedule for the portion of the Middletown - Norwalk Project which The Office of Long Island Sound has jurisdiction over. This includes the three crossings identified above. A prehearing conference occurred on October 31, 2006, a public hearing is scheduled for November 13, 2006 in Bridgeport and adjudicated hearings at DEP offices are scheduled to occur on November 20 (1/2 day) and 21, and if needed, November 27, 2006.

Will CL&P plant vegetation in place a 30" maple and (3) 12" spruce trees being removed at the Catholic Church of Assumption?

Response:

CL&P will provide financial compensation to the property owner or plant replacement trees from nursery stock, depending on the agreement reached during negotiations with the property owner for the easement on the property. Any replacement trees must be planted outside of CL&P's permanent easement, the edge of which is approximately 10 feet away from the edge of the duct bank or splice vault.

Please note that the 30" maple tree at the Catholic Church of the Assumption has been removed (not by CL&P or its contractor) and replaced with other landscaping.

NOTICE OF TENTATIVE DETERMINATION NOTICE OF INTENT TO WAIVE THE REQUIREMENT FOR **PUBLIC HEARING** 401 WATER QUALITY CERTIFICATION/ STRUCTURES, DREDGING & FILL #200402101-MG

Towns: Bethany, Bridgeport, Cheshire, Durham, Fairfield, Haddam, Hamden, Meriden, Middlefield, Middletown, Mil-ford, Norwalk, Orange, Stratford, Wallingford, West Haven, Westport, and Woodbridge Waters: Housatonic, Pequonnock, and Saugatuck Rivers, Ash Creek, Stony Brook, Sasco Creek, Mill River and wet-lands in Project Towns.

The Department of Environmental Protection hereby gives notice it has made a tentative determination to approve an application submitted by The Connecticut Light & Power Company and the United Illuminating Company (the "applicant") pursuant to Connecticut General Statutes (CGS) sections 22a-32 and 22a-361 for a permit to conduct activities located waterward of the high tide line and in tidal wetlands and pursuant to Section 401(a)(1) of the Federal Clean Water Act (the "Act") for the certification of activities, incidental to construction or operation of facilities, which may result in any discharge to State waters, associated with the proposed project to construct approximately 69 miles of new overhead and underground 345-kV electric transmission lines for the purpose of improving electric sys-tem reliability by enhancing transmission interconnections between Southwest Connecticut and the rest of the New England grid. England grid.

England grid. Specifically, the applicant proposes to conduct work affect-ing Connecticut's wellands and watercourses in associa-tion with the construction of approximately 69 miles of new overhead and underground 345-kV electric transmission lines extending from Middletown to Norwalk, Connecticut. The project traverses through Bethany, Bridgeport, Che-shire, Durham, Fairfield, Haddam, Hamden, Meriden, Mid-dlefield, Middletown, Milford, Norwalk, Orange, Stratford, Wallingford, West Haven, Wesport, and Woodbridge. Asso-ciated work will include construction of two new substations (East Devon Substation in Milford and Singer Substation in Bridgeport), a new switching station (Beseek Switching Station in Wallingford, site modifications to the existing Norwalk Substation in Norwalk and Scovill Rock Switching Station in Middletown, and reconfiguration of certain inter-connections and the reconstruction/consolidation of certain existing 115-kV transmission facilities within existing right-of-way limits. Horizontal directional drilling method is pro-posed for crossing underneath the Housatonic, Pequon-nock, and Saugatuck Rivers and Ash Creek. The Stony Brook stream crossing will be open cut.

The Director of the Bureau of Aquaculture at the Depart-ment of Agriculture has reviewed this proposal and has de-termined that it will not significantly impact any shellfish area. All interested persons are invited to comment on the tentative determination concerning the application. The Commissioner hereby publishes notice of her intent to waive the requirement for public hearing pursuant to CGS section 22a-32 provided that she shall hold a hearing if she receives a petition signed by twenty-five or more persons.
