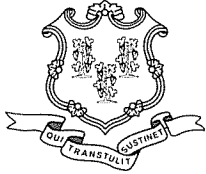

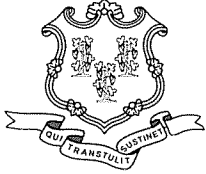


Dear Mr. Garfunkel:
