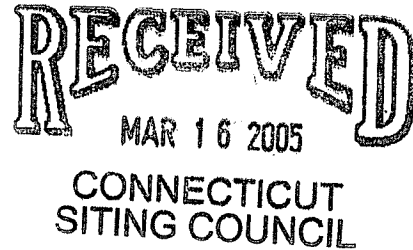

SOUTH CENTRAL CONNECTICUT REGIONAL WATER AUTHORITY'S
POST-HEARING BRIEF

I. INTRODUCTION

The Connecticut Light and Power Company and the United Illuminating Company (the "Companies") have applied to the Connecticut Siting Council (the "Council") for a Certificate of Environmental Compatibility and Public Need for a 345 kV electric transmission line and associated facilities between Scovill Rock switching station in Middletown and Norwalk substation in Norwalk, Connecticut (the "Project"). The South Central Connecticut Regional Water Authority ("RWA") is a party in this proceeding and

owns watershed land that portions of the Project will traverse. In the areas where the Project crosses watershed land, the existing transmission lines are supported by three sets of structures: two 57 foot tall wooden H-structures and one 80 foot tall lattice structure. The proposal requires removal of the existing structures and the construction of two steel monopoles approximately 80 feet tall. Cumulatively, over the length of the Project, approximately 100 acres of land that the RWA owns in Hamden, Orange, Bethany and Woodbridge will be affected. The removal of the existing transmission structures and the construction of the new structures will have the potential to cause adverse environmental impacts to public water supply resources and assets (such as reservoirs, aquifers, wetlands and watercourses), if certain precautions and Best Management Practices ("BMP") are not followed. The RWA has no objection to the proposed overhead transmission facilities on watershed land, provided that appropriate efforts are made to minimize the potential adverse impacts to water supply resources and assets. Accordingly, the RWA respectfully requests that the Council incorporate the specific conditions described herein into any favorable Decision and Order in this proceeding. The requested conditions will assure that certain regulatory requirements are met and that potential adverse impacts to watershed assets are eliminated or minimized.

II. DEPARTMENT OF PUBLIC HEALTH JURISDICTION OVER WATERSHED
LAND

As described in the RWA's testimony, certain activities on RWA-owned lands are regulated by the Connecticut Department of Public Health ("DPH") pursuant to Section 25-32 of the Connecticut General Statutes. See generally, Pre-filed Testimony of South Central Regional Water Authority by Thomas V. Chaplik. Based on a preliminary review of the Project, DPH staff determined that the RWA would need to obtain a Change of Use Permit for the proposed changes to the existing transmission right-of-way on RWA-owned property. The DPH also indicated that Project-related activities outside of the RWA-owned right-of-way, such as temporary access roads or staging areas, would also need to be included in the permit application. DPH informed the RWA that the application for the Change in Use Permit must include the following:

- evidence of a revocable license for construction activities on RWA-owned land;
- an estimate of how much Class I and Class II RWA land will be impacted during construction;
- an exact number of structures to be removed from RWA land and the number of new structures to be installed;
- the location of storage area, staging areas, field office areas and additional temporary access areas on RWA land;

- the location of sanitary facilities for the construction crew and any other individuals involved with the Project;
- the number and types of construction equipment to be used, including details on fueling locations and the methods for controlling spills during refueling;
- locations of all water discharges and an assurance that the discharge will adhere to Section 19-13 B32(i) of the CT Public Health Code, which requires all discharges to take place in excess of 100 feet from a watercourse that is tributary to a public water supply reservoir;
- specifics on how many sites will be active each day and if the RWA will need additional manpower to properly monitor the activities;
- the identification of all blasting areas and specific information on how the RWA will monitor dams and other important structures for damage during blasting;
- details on the long-term maintenance of the new facilities and the inclusion of an Integrated Pest Management Plan to limit the use of pesticides within the right-of-way.

The RWA respectfully requests that the Council require, as a condition of any approval, that the companies provide the RWA with the information that the DPH requires to issue a Change in Use permit.

III. MITIGATION OF ADVERSE IMPACTS ON NATURAL RESOURCES

Based on the RWA's testimony, construction activities have the potential to cause adverse impacts to wetlands and watercourses. For example, clearing vegetation and excavating for tower foundations, improving or widening access roads, and establishing equipment staging and storage areas, can lead to sedimentation and erosion. Other potential impacts include spills of diesel fuel gasoline, or other petroleum products from construction equipment, discharges of degraded water from dewatering, and residues from blasting. These activities are more likely to have a significant impacts to public water supply resources when taking place within close proximity of water bodies, wetland areas or on steep slopes uphill of water resources. However, without a specific description and location of the activities, it is difficult to determine exactly where the most vulnerable resources are and to identify the BMP or other measures that could be used to mitigate the likely impacts. Accordingly, it is imperative that the RWA have a meaningful opportunity to review and comment on a draft Development and Management Plan ("D&M Plan") and recommend the appropriate BMPs for the protection of water resources. Such recommendations could require the development and implementation of a Stormwater Pollution Prevention Plan ("SWPPP") establishing criteria for equipment refueling and storage of fuels and other hazardous materials.

IV. MITIGATING IMPACTS TO RWA'S INFRASTRUCTURE

As described in the RWA's testimony, the proposed transmission Project crosses, or is in close proximity to, many of the RWA's facilities, including water mains, dams, diversion tunnels, pressure reducing stations and water storage tanks. The construction of underground or overhead facilities, which may involve drilling and blasting, could damage RWA's facilities. To reduce or eliminate these impacts, the RWA respectfully requests that the Council include the following conditions as part of any favorable Decision and Order:

- The applicant shall provide reimbursement for all costs incurred by the RWA during work on the electric transmission line, including costs for review by the RWA and any of its special consultants, inspection costs during construction, and costs associated with designing and relocating the RWA's facilities, if required;
- preliminary and final D&M plans shall be provided to the RWA for their review and comments. The RWA shall be allowed at least 30 days to review and comment;
- between three and five days prior to construction in the vicinity of RWA facilities, the RWA must notified;
- if blasting is required, preblast surveys of RWA facilities shall be done, recording seismographs shall be in place during blasting, and copies of the surveys and seismograph results shall be provided to the RWA.


V. CONCLUSIONS

Based on the foregoing, the RWA formally requests that the Council incorporate the following conditions into any favorable Decision and Order:

1. The Companies shall provide all information necessary for the RWA to prepare a DPH Change in Use application and Revocable License Agreement for the construction activities on RWA owned watershed land.
2. The Companies shall prepare a SWPPP during the development of the D&M Plan. The D&M Plan shall be prepared in accordance with the Connecticut Guidelines for Soil Erosion and Sediment Control.
3. Refueling of construction equipment on public water supply watershed and aquifer areas shall be conducted over portable spill containment areas. Absorbent spill response materials shall be readily available on-site. The RWA shall be immediately notified of any hazardous material spills or other water quality incidents on its public water supply watershed or aquifers.
4. Any fuel, oils, paints, solvents, or other hazardous materials stored on-site during the construction process shall be in a secure area with at least 110 percent secondary containment.

5. The Companies shall submit an Integrated Pest Management Plan for long-term maintenance of right-of-ways and submit an annual summary of pesticide use and other maintenance activities on RWA property.
6. If blasting is required, pre-blast surveys of RWA facilities shall be done, recording seismographs shall be in place during blasting, and copies of the survey and seismograph results shall be provided to the RWA.
7. The applicant shall provide reimbursement for all costs incurred by the RWA regarding review and inspection of the Project, including costs for review by the RWA and any of its special consultants, inspection costs during construction, and costs associated with designing and relocating the RWA's facilities, if required.
8. Preliminary and final D&M Plans shall be provided to the RWA for its review comment. The RWA shall be allowed at least 30 days to review and comment.
9. The RWA shall receive between three and five days notice prior to commencement of construction activity on public water supply watershed or aquifers, or in the vicinity of RWA facilities.


