AFFIDAVIT


I, Donald W. Roe, the undersigned, having been duly sworn on my oath, do hereby depose and state:

8. The Photographs in Appendix A are true and accurate representations of the Williams Farm property as of the date hereof.



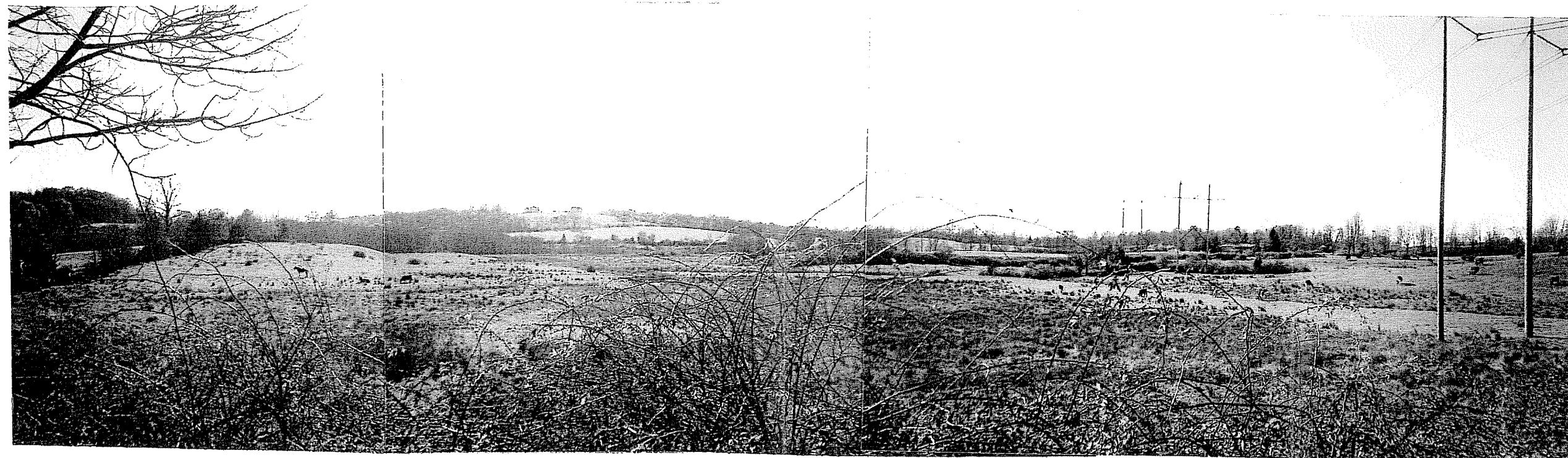

VIEW TO THE SOUTH FROM EAST CENTER STREET




VIEW TO THE NORTH FROM TAMARAC SWAMP ROAD

AFFIDAVIT


I, Raymond J. Ross, the undersigned, having been duly sworn on my oath, do hereby depose and state:
