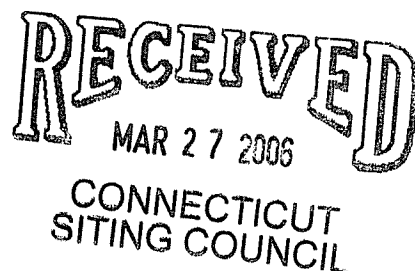

In reference to the forecast of capacity savings from demand-side measures that was provided to ISO New England's forecasting group for use in developing the ISO's 2005 energy and peak load forecast: Please identify for each demand-side program and for each year through 2015 (a) the capacity savings attributable to prior (e.g., through year-end 2005) activity under the program, and (b) the capacity savings attributable to future activity under the program.
3. (a) Please provide a copy of the forecast of capacity savings from demand-side measures that the Company provided to ISO New England's forecasting group for use in developing the ISO's 2006 energy and peak load forecast. (b) Please explain whether this information was used by the ISO-NE in developing its 2006 peak load forecast. If ISO-NE did not incorporate the information provided into its 2006 Forecast, please provide any information you may have as to why it did not.
4. In reference to the forecast of capacity savings from demand-side measures that the Company provided to ISO New England's forecasting group for use in developing the ISO's 2006 energy and peak load forecast, please identify for each demand-side program and for each year through 2015 (a) the capacity savings attributable to prior activity under the program, and (b) the capacity savings attributable to future activity under the program.
5. Please identify the Company's current forecast of capacity savings from its contributions to ISO load response programs. Please identify both programs and forecast capacity savings for each program.
