**2026 NUTMEG SOLAR, LLC
ANNUAL REPORT FOR THE CONNECTICUT SITING COUNCIL
REVIEW OF TEN-YEAR FORECAST OF CONNECTICUT ELECTRIC LOADS AND
RESOURCES**

Pursuant to the provisions of Section 16-50r of the Connecticut General Statutes, Nutmeg Solar, LLC (“Nutmeg”) hereby submits this report of its ten-year forecast of loads and resources:

(1) A tabulation of estimated peak loads, resources and margins for each year.

The Nutmeg Solar Facility (the “Facility”) has the capacity to generate 19.6 megawatts (MW) AC of electricity. As a wholesale power producer, Nutmeg does not have a franchise territory within which it would estimate peak load requirements or margins for the period, and therefore, no such estimates are offered.

(2) Data on energy use and peak loads for the five preceding calendar years.

Nutmeg received its permission to operate from the interconnecting utility company (Eversource) on December 7, 2020. Prior to 2020, the Facility was not operational. Nutmeg generated 34,524.78 MWh in 2025, 34,401.85 MWh in 2024, 33,367.10 MWh in 2023, 38,314.90 MWh in 2022, 35,124.93 MWh in 2021 and 1,500 MWh in 2020.

(3) A list of existing generating facilities in service.

The Facility is Nutmeg Solar, LLC’s sole power generating asset in Connecticut and has the capacity to generate 19.6 MW AC of electricity.

(4) A list of scheduled generating facilities for which property has been acquired, for which certificates have been issued and for which certificate applications have been filed.

(5) A list of planned generating units at plant locations for which property has been acquired, or at plant locations not yet acquired, that will be needed to provide estimated additional electrical requirements, and the location of such facilities.

(6) A list of planned transmission lines on which proposed route reviews are being undertaken or for which certificate applications have already been filed.
