## Minutes of December 2, 2010.

Mr. Murphy moved to approve the Minutes of December 2, 2010, seconded by Dr. Bell. The motion passed unanimously.

DOCKET NO. 225 - Kleen Energy Systems, LLC Certificate of Environmental Compatibility and Public Need for the construction, maintenance and operation of a Electric Generating Facility and Switchyard on River Road, Middletown, Connecticut. Revision to Development and Management Plan.

Mr. Ashton moved to approve the Emergency Response Plan as an interim plan for the construction phase, seconded by Mr. Wilensky. The motion passed unanimously.

Council Member Mr. Levesque joined the meeting at 2:25 p.m.

DOCKET NO. 338 – TowerCo. Certificate of Environmental Compatibility and Public Need for the construction, maintenance and operation of a telecommunications facility located at 160 West Street, Cromwell, Connecticut. Request for Extension.

Mr. Murphy moved to approve the Extension of time to complete construction until March 29, 2011, seconded by Mr. Ashton. The motion passed unanimously.

DOCKET NO. 398 - Northeast Utilities Service Company, on behalf of The Connecticut Light and Power Company (CL&P) Certificate of Environmental Compatibility and Public Need for the construction, maintenance and operation of the Sherwood Substation located at 6 New Creek Road, Westport, Connecticut. Development and Management Plan Modifications.

Mr. Ashton moved to approve the modifications to the Development and Management Plan, seconded by Mr. Wilensky. The motion passed unanimously.

DOCKET NO. 412 - SBA Towers III LLC and New Cingular Wireless PCS, LLC application for a Certificate of Environmental Compatibility and Public Need for the construction, maintenance and management of a telecommunications facility located at Wewaka Brook Road, Bridgewater, Connecticut. Completeness Review.

Mr. Murphy moved to approve the application as complete and the appointment of Lisa Fontaine as custodian of the docket, seconded by Dr. Bell. The motion passed unanimously.

PETITION NO. 937 - The Connecticut Municipal Electric Energy Cooperative (CMEEC) petition for a declaratory ruling that no Certificate of Environmental Compatibility and Public Need is required for the installation of two 2.5 MW electric generators and associated equipment at two existing substation locations, 15 Old Colony Road and 130 Thorpe Avenue, Wallingford, Connecticut. Decision.

Mr. Ashton moved to remove this item from the table, seconded by Mr. Wilensky. The motion passed unanimously.

Mrs. Roberts informed the Council that CMEEC has submitted a letter withdrawing this petition.

PETITION NO. 971 - T-Mobile USA, Inc. petition for a declaratory ruling that no Certificate of Environmental Compatibility and Public Need is required for the attachment of antennas to an existing CL&P transmission structure located at Oil Mill Road, Waterford, Connecticut. Date for Decision.

Mr. Murphy moved that Council will act on this petition by January 31, 2011; seconded by Dr. Bell. The motion passed unanimously.

PETITION NO. 973 - North Atlantic Towers, LLC and New Cingular Wireless PCS, LLC petition for a declaratory ruling that no Certificate of Environmental Compatibility and Public Need is required to replace and expand an existing structure located at 880 Andrew Mountain Road, Naugatuck, Connecticut. Date for Decision.

Mr. Tait moved to hold a hearing on this petition, seconded by Mr. Lynch. The motion passed unanimously.

PETITION NO. 976 - PSEG New Haven LLC petition for a declaratory ruling that no Certificate of Environmental Compatibility and Public Need is required for the modifications relating to the installation and operation of three 48.5 MW peaking units at New Haven Harbor Station, New Haven, Connecticut. Decision.

Mr. Ashton moved to approve this petition, seconded by Mr. Wilensky. The motion passed unanimously.

Mr. Tait moved that this project is exempt from Siting Council jurisdiction under Conn. Gen. Stat. § 16-50i(a)(3), seconded by Mr. Murphy. The motion passed unanimously.

TS-CLEARWIRE-152-101129 - Clear Wireless LLC request for an order to approve tower sharing at an existing telecommunications facility located at 15 Miner Lane, Waterford, Connecticut.

Mr. Murphy moved to approve this tower share request, seconded by Dr. Bell. The motion passed unanimously.
