Minutes of May 15, 2014.

Mr. Ashton moved to approve the minutes of May 15, 2014; seconded by Mr. Lynch. The motion passed with Dr. Klemens and Mr. Hannon abstaining.

Mr. Ashton moved to approve the Transfer of Certificate from T-Mobile Northeast LLC to

Phoenix Partnership LLC, seconded by Mr. Murphy. The motion passed unanimously.

Dr. Klemens moved to approve a one year extension of time until October 26, 2015, to complete this project, seconded by Mr. Ashton. The motion passed unanimously.

Dr. Klemens moved to have the petitioner erect a sign on the property describing the proposal to provide additional notice and to set October 18, 2014, as the date by which the Council shall make its decision, seconded by Mr. Murphy. The motion passed unanimously.

PETITION NO. 1102 – Cellco Partnership d/b/a Verizon Wireless and New Cingular Wireless PCS, LLC (AT&T) petition for a declaratory ruling that no Certificate of Environmental Compatibility and Public Need is required for the installation of a temporary ballast tower and associated equipment on property located at the American School for the Deaf, 139 North Main Street, West Hartford, Connecticut. Decision.

Mr. Murphy moved to approve the petition with the following conditions:

- The petitioner shall stabilize any ground disturbance before the winter months; and
- The petitioner shall erect a sign notifying the public that the facility is temporary.

The motion was seconded by Mr. Caron. The motion passed unanimously.

TS-AT&T-128-140506 - AT&T request for an order to approve tower sharing at an existing telecommunications facility located at 345 Bushy Hill Road, Simsbury, Connecticut. Decision.

Mr. Caron moved to approve this tower share request, seconded by Mr. Ashton. Mr. Caron withdrew his motion.

Mr. Murphy moved to table this item, seconded by Mr. Lynch. The motion passed unanimously.

TS-CING-054-131008-Revised – New Cingular Wireless PCS, LLC request for an order to approve tower sharing at an existing telecommunications facility located at 58A Montano Road, Glastonbury, Connecticut. Request to Revise.

Mr. Murphy moved to approve this revision to a previously approved tower share request with the following conditions:

- The proposed feed lines and accessory equipment shall be utilized in accordance with the recommendations of the structural analysis report prepared by FDH Engineering dated May 5, 2014 and stamped by Bradley Newman; and
- Within 45 days following completion of the equipment installation, AT&T shall provide documentation certified by a professional engineer that its installation complied with the recommendations of the structural analysis.

The motion was seconded by Mr. Caron. The motion passed unanimously.

TS-VER-036-140512– Cellco Partnership d/b/a Verizon Wireless request for an order to approve tower sharing at an existing telecommunications facility located at 220 Winthrop Road, Deep River, Connecticut. Decision.

Mr. Caron moved to approve this tower share request with the following conditions:

- The proposed coax and remote radio heads shall be installed in accordance with the recommendations made in the Structural Analysis Report prepared by FDH Engineering dated November 4, 2013 and stamped by Bradley Newman; and
- Not more than 45 days following completion of the antenna installation, Cellco shall provide documentation certifying that its installation complied with the engineer's recommendation.

The motion was seconded by Mr. Ashton. The motion passed unanimously.
