Minutes of October 16, 2014.

Mr. Lynch moved to approve the minutes of October 16, 2014, seconded by Mr. Caron. The motion passed with Dr. Klemens abstaining.

DOCKET NO. 449 – Message Center Management and New Cingular Wireless PCS, LLC application for a Certificate of Environmental Compatibility and Public Need for the construction, maintenance, and operation of a telecommunications facility located at Redding Tax Assessor Map 23, Lot 72, Redding Ridge Fire Department, 186 Black Rock Turnpike, Redding, Connecticut. Draft Findings of Fact, Opinion, and Decision & Order.

Mr. Ashton moved to approve the Findings of Fact, Opinion, and Decision & Order, as amended, seconded by Dr. Klemens. The motion passed unanimously.

DOCKET NO. 452 - Homeland Towers, LLC and New Cingular Wireless PCS, LLC application for a Certificate of Environmental Compatibility and Public Need for the construction, maintenance, and operation of a telecommunications facility located at Salisbury Tax Assessor Map 16 Lot 5, 250 Canaan Road, Salisbury, Connecticut. Completeness Review, Schedule, Custodian of the Docket, Deposition of the Transcript, Motion for Protective Order.

Mr. Ashton moved to deem the application as complete, approve the schedule for processing the docket as per staff recommendations, the appointment of Carriann Mulcahy as custodian of the docket, the deposition of the transcript in the Town of Salisbury, a public field review and a public hearing in the Town of Salisbury on Thursday, December 4, 2014, seconded by Mr. Lynch. The motion passed with Dr. Klemens recusing.

Mr. Ashton moved to approve the Motion for Protective Order, seconded by Mr. Caron. The motion passed with Dr. Klemens recusing.

PETITION NO. 1104 – The United Illuminating Company petition for a declaratory ruling that no Certificate of Environmental Compatibility and Public Need is required for the proposed construction, maintenance and operation of a 2.2 MW AC solar photovoltaic facility and a 2.8 MW AC Fuel Cell facility on approximately 22 acres of the former Seaside Landfill located at 350 Waldemere Avenue, Bridgeport, Connecticut. Draft Findings of Fact.

After reviewing the Draft Findings of Fact, Vice Chairman Murphy conducted a non-binding straw poll with Mr. Caron, Mr. Hannon, Dr. Bell, Dr. Klemens, and Vice Chairman Murphy in favor of the proposed petition, with Mr. Ashton in favor of the fuel cell portion of the petition and against the solar photovoltaic facility, and Mr. Lynch passing.

Vice Chairman Murphy directed staff to draft a favorable Opinion and Decision and Order for the proposed petition to be reviewed at the next meeting.

PETITION NO. 1118 - Cellco Partnership d/b/a Verizon Wireless petition for a declaratory ruling that no Certificate of Environmental Compatibility and Public Need is required for a proposed rooftop telecommunications facility on an existing building located at 1 Selleck Street, Norwalk, Connecticut. Set Date for Decision.

No action was taken on this item, as it was withdrawn.
