Minutes of April 14, 2016.

Dr. Klemens moved to approve the minutes of April 14, 2016, seconded by Mr. Murphy. The motion passed with Mr. Harder abstaining.

DOCKET NO. 461 - Eversource Energy application for a Certificate of Environmental Compatibility and Public Need for the construction, maintenance, and operation of a 115-kilovolt (kV) bulk substation located at 290 Railroad Avenue, Greenwich, Connecticut, and two 115-kV underground transmission circuits extending approximately 2.3 miles between the proposed substation and the existing Cos Cob Substation, Greenwich, Connecticut, and related substation improvements. Draft Findings of Fact.

The item was passed temporarily.

DOCKET NO. 465 - The United Illuminating Company application for a Certificate of Environmental Compatibility and Public Need for the construction, maintenance, and operation of a 115/13.8-kilovolt (kV) replacement substation facility located on an approximately 1.5 acre portion of two adjoining UI-owned parcels directly adjacent to UI's existing Baird Substation, 1770 Stratford Avenue, Stratford, Connecticut, and related transmission structure and interconnection improvements. Draft Findings of Fact, Opinion, and Decision & Order.

Mr. Ashton moved to approve the Draft Findings of Fact, Opinion, and Decision & Order, seconded by Mr. Murphy. The motion passed with Mr. Harder abstaining.

PETITION NO. 1217 - Eversource Energy petition for a declaratory ruling that no Certificate of Environmental Compatibility and Public Need is required for the proposed separation of the existing 1779/1777 115 kilovolt (kV) electric transmission lines for 1.6 miles within existing right of way from Bloomfield Substation to Bloomfield Junction; proposed separation of the existing 1751/1777 115kV electric transmission lines for 5.3 miles within existing right of way from Bloomfield Junction to North Bloomfield Substation; modifications to the existing overhead 1779 115 kV electric transmission line to loop into the Rood Avenue Substation via underground cables; including related transmission line structure improvements; and modifications to the Bloomfield Substation, 40 Crestview Drive and North Bloomfield Substation, 2 Hoskins Road both in Bloomfield, Connecticut and modifications to the Rood Avenue Substation located at 275 Rood Avenue, Windsor, Connecticut, Decision.

Mr. Hannon moved to approve this petition, seconded by Dr. Klemens for discussion purposes. Chairman Stein conducted a poll of the Council members with Mr. Lynch, Mr. Levesque, Mr. Hannon, and Chairman Stein in favor of approving the petition with the conditions noted in the staff report and the condition that Eversource submit a Development & Management Plan for the project along with a vernal pool study and wildlife analysis for the blue spotted salamander and marbled salamander with proposed protective measures as applicable, with Mr. Murphy, Dr. Klemens and Mr. Ashton opposed, and with Mr. Harder abstaining.

DOCKET NO. 461 - Eversource Energy application for a Certificate of Environmental Compatibility and Public Need for the construction, maintenance, and operation of a 115-kilovolt (kV) bulk substation located at 290 Railroad Avenue, Greenwich, Connecticut, and two 115-kV underground transmission circuits extending approximately 2.3 miles between the proposed substation and the existing Cos Cob Substation, Greenwich, Connecticut, and related substation improvements. Draft Findings of Fact.

Dr. Klemens and Mr. Levesque stated for the record that they read the record and the transcripts of the proceeding.

Mr. Hannon and Mr. Murphy stated for the record that they read the transcript of the hearing of March 10, 2016.

After reviewing the Draft Findings of Fact, Chairman Stein conducted a non-binding straw poll of the Council members with Mr. Murphy, Dr. Klemens, Mr. Ashton, and Chairman Stein in favor of

denying the application without prejudice, Mr. Levesque and Mr. Hannon in favor of approving the application, and Mr. Lynch and Mr. Harder abstaining.

Chairman Stein directed staff to draft an Opinion and Decision and Order denying the application without prejudice to be reviewed at the next meeting.
