# Meeting Minutes Meeting of October 10, 2019

#### 1. Minutes of September 12, 2019.

Mr. Lynch moved to approve the minutes of September 12, 2019; seconded by Mr. Hannon. The motion passed unanimously.

### 2. FORECAST-2018/2019 - Connecticut Siting Council 2019 Ten-Year Forecast of Connecticut Electric Loads and Resources. Public Comment Session Schedule.

Mr. Lynch moved to approve the Public Comment Session Schedule as per staff recommendations; second by Mr. Hannon. The motion passed unanimously.

3. PETITION NO. 754 - Best Management Practices for Electric and Magnetic Fields. Annual Review.

Mr. Hannon moved that no revisions be made to the Council's current Best Management Practices for Electric and Magnetic Fields, dated February 20, 2014; seconded by Mr. Lynch. The motion passed unanimously.

4. PETITION NO. 1378 - Greenskies Renewable Energy, LLC (GRE) petition for a declaratory ruling, pursuant to Connecticut General Statutes §4-176 and §16-50k, for the proposed construction, maintenance and operation of a 5.0-megawatt AC solar photovoltaic electric generating facility on approximately 16.5 acres located generally east of Taugwonk Road and Taugwonk Spur Road and north of Interstate 95 in Stonington, Connecticut and associated electrical interconnection. Decision.

Mr. Hannon moved to approve this petition with the conditions noted in the staff report and the additional conditions that an Invasive Species Management Plan and the final Farmland Restoration Plan be submitted to the Council; seconded by Mr. Lynch. The motion passed unanimously.

5. PETITION NO. 1379 - Cellco Partnership d/b/a Verizon Wireless petition for a declaratory ruling, pursuant to Connecticut General Statutes §4-176 and §16-50k, for the proposed installation of a wireless telecommunications facility on the roof of an existing building located at 1270 North High Street (a/k/a State Route 100), East Haven, Connecticut. Decision.

Mr. Hannon moved to table this item pending the receipt of additional information; seconded by Mr. Lynch. The motion passed unanimously.

6. TS-CING-105-190808 – New Cingular Wireless PCS, LLC (AT&T) request for an order to approve tower sharing at an existing telecommunications facility located 232 Shore Road, Old Lyme, Connecticut. Decision.

Mr. Harder moved to remove this item from the table; seconded by Mr. Hannon. The motion passed unanimously.

Mr. Harder moved to approve this tower share request with the condition that approval of any minor changes be delegated to Council staff; seconded by Mr. Hannon. The motion passed unanimously.

7. Connecticut Siting Council Revised Fiscal Year 2021 Proposed Budget.

Mr. Lynch moved to present the budget to the energy and telecommunications industries for comment; seconded by Mr. Hannon. The motion passed unanimously.
