#### 1. Minutes of March 24, 2022.

Mr. Silvestri moved to approve the Minutes of March 24, 2022; seconded by Mr. Quinlan. The motion passed with Mr. Lynch abstaining.

2. **DOCKET NO. 501 - New Cingular Wireless PCS, LLC Certificate of Environmental Compatibility and Public Need for the construction, maintenance, and operation of a telecommunications facility located at 106 Sharon Road, Lakeville (Salisbury), Connecticut. Development and Management Plan.**

Mrs. Cooley moved to approve the Development and Management Plan with the condition noted in the staff report; seconded by Mr. Collette. The motion passed unanimously.

3. **DOCKET NO. 503 - Arx Wireless Infrastructure, LLC Certificate of Environmental Compatibility and Public Need for the construction, maintenance, and operation of a telecommunications facility located at 43 Osgood Avenue, New Britain, Connecticut. Development and Management Plan.**

Mr. Quinlan moved to approve the Development and Management Plan; seconded by Mr. Lynch. The motion passed with Mr. Morissette abstaining.

4. **DOCKET NO. 506 - New Cingular Wireless PCS, LLC (AT&T) application for a Certificate of Environmental Compatibility and Public Need for the construction, maintenance, and operation of a telecommunications facility located at 499 Mile Lane, Middletown, Connecticut. Motion to Reopen the Evidentiary Record. Request for Party/Intervenor Status.**

Mr. Silvestri moved to deny the Motion to Reopen the Evidentiary Record; seconded by Mr. Collette. The motion passed unanimously.

5. **DOCKET NO. 507 – Homeland Towers, LLC and Cellco Partnership d/b/a Verizon Wireless application for a Certificate of Environmental Compatibility and Public Need for the construction, maintenance, and operation of a wireless telecommunications facility located at 222 Clintonville Road, North Branford, Connecticut. Request to Submit Supplemental Information into Evidentiary Record.**

Mr. Silvestri moved to approve the Request to Submit Supplemental Information into the Evidentiary Record; seconded by Mr. Quinlan. The motion passed unanimously.

Mr. Silvestri moved to admit the late-filed exhibits into the record without an additional hearing; seconded by Mrs. Cooley. The motion passed unanimously.

6. **PETITION NO. 1485 - Bloom Energy Corporation petition for a declaratory ruling, pursuant to Connecticut General Statutes §4-176 and §16-50k, for the proposed construction, maintenance and operation of a customer-side 2-megawatt fuel cell facility and associated equipment to be located at Stamford Hospital, 1 Hospital Plaza, Stamford, Connecticut. Decision.**

Mr. Collette moved to approve this petition with the conditions noted in the staff report and with the recommendation that bollards be installed at the curve of the Emergency Room driveway east of the fuel cell and along Hospital Plaza south of the fuel cell, if the locations of the additional bollards will not interfere with hospital operations or any existing underground utilities at the site; seconded by Mr. Silvestri. The motion passed unanimously.

7. **PETITION NO. 1486 – The Connecticut Light and Power Company d/b/a Eversource Energy petition for a declaratory ruling, pursuant to Connecticut General Statutes §4-176 and §16-50k, for the proposed 400/500 Lines Rebuild Project consisting of the upgrade of the existing No. 400 69-kilovolt (kV) electric transmission line to 115-kV and the replacement and reconductoring of electric transmission line structures along 8.6 miles of the existing No. 400 electric transmission line within existing Eversource electric transmission line right-of-way between Ledyard Junction in Ledyard and Tunnel Substation in Preston; and the replacement and reconductoring of electric transmission line structures along approximately 4.9 miles of the existing No. 500 69-kV electric transmission line within existing Eversource electric transmission line right-of-way between Hallville Junction in Ledyard and Tunnel Substation in Preston Connecticut, and related electric transmission line and substation improvements. CGS §4-176 Deadline for Action - Set Date for Decision.**

Mr. Lynch moved to set the date by which to render a decision in accordance with Connecticut General Statutes § 4-176(e) and Section 16-50j-40(c) of the Regulations of Connecticut State Agencies, as no later than August 7, 2022; seconded by Mr. Collette. The motion passed unanimously.

8. **PETITION NO. 1487 – TRITEC Americas, LLC petition for a declaratory ruling, pursuant to Connecticut General Statutes §4-176 and §16-50k, for the proposed construction, maintenance and operation of a 1.97 megawatt AC solar photovoltaic electric generating facility located at 254 Putnam Road, Pomfret, Connecticut, and associated electrical interconnection. CGS §4-176 Deadline for Action - Set Date for Decision.**

Mr. Collette moved to set the date by which to render a decision in accordance with Connecticut General Statutes § 4-176(e) and Section 16-50j-40(c) of the Regulations of Connecticut State Agencies, as no later than August 9, 2022; seconded by Mr. Lynch. The motion passed unanimously.

9. **PETITION NO. 1488 - T-Mobile Northeast, LLC (T-Mobile) petition for a declaratory ruling, pursuant to Connecticut General Statutes §4-176 and §16-50k, for proposed modifications to an existing telecommunications facility on electric transmission line structure No. 3147, owned by Eversource Energy within an existing Eversource Energy electric transmission line right-of-way located at 140 Duncaster Road, Bloomfield, Connecticut. CGS §4-176 Deadline for Action - Set Date for Decision.**

Mr. Silvestri moved to set the date by which to render a decision in accordance with Connecticut General Statutes § 4-176(e) and Section 16-50j-40(c) of the Regulations of Connecticut State Agencies, as no later than August 14, 2022; seconded by Mrs. Cooley. The motion passed unanimously.
