1. Minutes of August 18, 2022.

Mr. Silvestri moved to approve the Minutes of August 18, 2022; seconded by Mr. Lynch. The motion passed unanimously.

2. **FORECAST-2022 - Connecticut Siting Council 2022 Review of the Ten-Year Forecast of Connecticut Electric Loads and Resources. LIFE-CYCLE 2022 - Connecticut Siting Council 2022 Analysis of Life-Cycle Costs of Electric Transmission Lines. Joint Public Comment Session Schedule.**


