## Section 4: Respond to a Solicitation

All Solicitation responses must be *electronically uploaded* to **CTsource**. No hard copy (paper) responses will be accepted. Each firm is solely responsible for ensuring timely submission of their Solicitation response. Failure to allow adequate time prior to the end date and time of the Solicitation to complete and submit a response, particularly if technical support assistance is required, places the firm and their response at risk of not being accepted on time. 		All projects greater than \$500,000 require a bidder to be currently prequalified. To find the specific prequalification requirements for a project, see page 1 of the Invitation to Bid under "Bidding Limited To". The Invitation to Bid can be downloaded from the DAS Construction Services Bid Board on CTsource ( <u>https://portal.ct.gov/DAS/Construction-Services/BidBoard</u> ).
