- CT Library Fiber Consortium Fiber to the Library (FTTL)
 - Project to connect libraries through federal E-rate and matching State Library bonded funds.
 - Many project sites connect underserved communities where connectivity options have remained relatively unchanged for decades. This project provides high-quality service at reasonable costs to bridge gaps in the digital divide and help libraries continue to thrive as community assets.
 - One library from phase 5 is lingering and is under construction, summer 2022 completion.
 - Phase 7: 5 Fiber builds are scheduled with late Spring completion dates.
 - Phase 8: Awarded February 21, 2022, 64 libraries eligible.
 - The current project across all phases (1–7) will bring total fiber-connected libraries to 146 representing 76% of all 191 libraries statewide
- CT Library Fiber Consortium Internal Connections (FTTL-IC)
 - New Program announced December 3, 2021. <u>https://ctedunet.net/fttl-ic/</u>
 - Goal is to help libraries with internal network infrastructure to better serve library operations
 - Libraries received assessments, prioritized remediation plans, and awards to assist each.
 - Items include switches, routers, WiFi Access points, UPS', target wiring upgrades
 - Call for applicants closed on Feb 21, 2022. 41 libraries applied.
 - Libraries will be put forward for approval from State Library Board on Mar 23, 2022
 - Network infrastructure Assessments begin April 2, 2022

2. Ignite Innovation

- eduroam https://www.eduroam.us/
 - Goal is to address digital divide issues impacting students learning and provide more seamless network access experience for students
 - Tom Dillon helping coordinate activities as CET Infrastructure Advisory Council Chair, with CEN resources and fiscal support. This is a crossover item between CET Infrastructure Advisory and CEN Service Management Advisory Councils.
 - Suffield Academy, Waterbury Public Schools, Darien Public Schools, and Coventry Public Schools have expressed interest in moving forward and have been provided a 90-day trial process (which can be extended). Goodwin University has initiated their own license agreement.
 - 71 respondents to Secure WiFi & eduroam readiness in schools and libraries. Will re-send and collect more info
 - Preparing an application for Internet2 eduroam Support Organization due in March
 - Additional services are in development and will be prioritized based on community feedback
 - With help of SMAC Chair(s), items are categorized and prioritized
 - Unified Communications RFP team meeting monthly to define service categories and requirements and targeting Q3 for RFP publication.
 - UConn procurement will assist with RFP development
 - Aligning initiatives with the existing UConn RFP cycle where possible to make more efficient use of time and effort.

 - Awards will be presented at the CEN annual conference
- Government Accountability Office (GAO)
 - Doug Casey (CET) and Ryan Kocsondy (CEN) met with representatives of the GAO to discuss federal efforts to assist K-12 schools to address cyber threats and recover from cyber incidents, and nonfederal views about the adequacy of federal efforts.
 - GAO wanted to understand and obtain information on current cybersecurity issues and challenges at K-12 schools and obtain their views on how to address cyber threats and what they think the federal government should be doing to help resolve cybersecurity issues at K-12 schools.
 - Aside from sharing information and advocating for K-12 specific needs, we assisted with outreach to representative districts and encouraged them to share information directly.
- Internet2 CAP Scholarship Recipients from CEN Membership/Connecticut schools.
 - 15 CT teachers received scholarship awards out of 31 across the US.
 - Over 1200 students will benefit from the scholarships across the U.S.
 - Winning teachers came from schools that connected through 4 different R&E networks.
 - Each teacher will receive a free one-on-one interactive online course of their choosing from the Center for Interactive Learning and Collaboration (CILC.org). These one-on-one courses usually cost between \$84 and \$336 each.

- Everybody Learns WiFi Expansion
 - \$10M Authorized in June 2021 Special Session for CEN to expand community WiFi
 - Program will be a grant funded to directly attached CEN members, may be used to physically connect sites as needed.
 - CEN working with CET Infrastructure council to advise on program eligibility criteria, application intake, scoring/ranking, and awards.
 - Federal guidance on ARPA program criteria and how to apply for funding was delivered end of January, application in draft and will be submitted in March.

5. Enhance Core Resources

- CEN Staff
 - CEN currently has 11 full-time staff members, 4 part-time student workers, and 1 volunteer (1 day /week)
 - Peter Correia was hired as Financial Manager on Jan 28, 2022
 - Current Job searches
 - Network Security Analyst 2 Re-Post
 - Network Engineer 1 or 2 Interviewing
- GlobalNOC Tier 2 Services
 - In February, CEN increased partnership commitment with GlobalNOC to provide supplemental Tier2 Engineering support. This new arrangement will maintain SLO targets to the CEN community while freeing up CEN Engineers to perform more irregular work, projects, pursue training, and serve as subject matter expertise (SME) and Tier3 and escalation support.
- Infrastructure Investments
 - CEN was allocated ~ \$2.5M in CEPF funds for equipment maintenance improvements to the infrastructure. This was less than the requested amount and items are being re-prioritized, requoted, and sequenced based on price and availability of equipment.
 - Of Note Component delays are impacting lead times for items such as routers and switches. Lead times can be anywhere from 120-180 days for orders with little relief in sight.
- Governor's Biennium Budget, HB5037, American Rescue Plan Act Coronavirus Relief Fund (ARPA-CPF)
 Monies

 - \$19.8M Grant Funding for municipalities and libraries to connect to CEN
