1) MINUTES

- a) A motion (KF) was made and seconded (GN) to accept the minutes of the **March 8, 2023**, meeting minutes. **All in favor. None opposed. Motion carried.**

- a) **A-23-05 RE:** Request for Appeal received 4/5/23 from David Taylor RE: [111 Founders Pl/323 Pitkin Street, East Hartford, CT] 2022 CSFSC Part IV 39.4.2.1. Appellant is asking the C&S Committee to review the compliance plan submitted to the East Hartford Fire Marshal (John Pelow) and reverse his decision to reject this plan. **A motion to refer to the OSFM (KF), seconded by (MS). All in favor, none opposed.**

- i) **Omarys Vasquez, State Building Inspector** – Continuous recruitment for State Building Inspectors. I sent errata updates to the committee. If everyone approves, we will post to our website.

6) APPEAL HEARINGS

- a) **A-06-21 RE:** Request for Appeal received 06/02/21 from Mr. Mayer Muller, Owner; common Hartford Accommodation RE: [2370-2374 Main Street, Hartford, CT]. Order to Vacate due to Fire/Life Safety Hazards – Connecticut State Fire Safety CGS Section 29-306(c). Appeal was originally held over to August 2021 meeting. Mr. Mayer has recently reached out to request a hearing on the appeal. Keith Flood will meet with Counsel. A motion (HM) was made and seconded (PC) to hold on the agenda until we receive a report from staff and counsel by the January

2023, meeting. All in favor. None opposed. Motion carried. Counsel reports that there was a verbal order issued to vacate the building based on five emergency circumstances; followed up with a written abatement order that listed approximately a dozen fire safety code violations. Therefore, the property owner is entitled to pursue an appeal to this committee on the fire safety code abatement order and listed violations. However, Applicant no longer owns the building. Counsel will draft letter limited to fire safety code violations which falls under the jurisdiction of the Codes & Standards Committee. Hearing scheduled: March 8, 2023; 9:00 a.m. Hearing held; appeal dismissed due to lack of jurisdiction of the Codes & Standards Committee. Decision will be mailed out in 90 days (June 8, 2023). **The decision will be mailed out in 30 days. Hold on agenda.**

Referred to OSBI. OSBI worked with Building Official. We will await the withdrawal. Omarys Vasquez, State Building Inspector will follow up on status. OSBI will contact Building Official to see if proper notice was given. Also, will reach out to Appellant for a withdrawal. OSBI confirmed with Building Official that everything has been settled. They have refunded the fine to the applicant. Omarys will follow up to request formal withdraw of appeal. **Hold on agenda.**
- e) **C-22-01** Complaint regarding Richard Leighton, Chester Building Inspector and Fire Marshal RE: [43-45-47 Main Street, Chester, CT] received 5/3/22 from John R. Schroeder, AIA LLC jrschroeder@jrsaia.com, 69-2 Main Street, Chester, Connecticut 06412, (860)526-5838. Referred to OSBI. OSBI is still working with the parties. Omarys Vasquez, State Building Inspector, reports that she is actively engaged with the Complainant. OSBI directed their team to investigate this matter. OSBI reached out to Appellant. However, they wish to meet with this Committee. In the past we turned it over to the State Police for investigation. Hold on agenda for procedure. Referred to C&S Committee Chair, Vice Chair and Secretary. OSBI will send files and information received from the Appellant for panel to evaluate for proper procedure. Meeting scheduled: February 28,

2023 – 9: 00.m. Referred to OSBI to seek more information from Complainant to substantiate complaint. **OSBI has emailed the Complainant to request additional information on 4/12/23 – awaiting a reply from Appellant. Hold on agenda.**

This is in reference to the building permits issued for buildings located RE: [189-191 Middlesex Avenue, Chester, CT] received 5/3/22 from Mr. Thomas A. Gribbin A.I.A., tomgribbin@noyesvogtarchitects.com, Noyes Vogt Architects, 191 Middlesex Ave, Suite 2A, P.O. Box 370, Chester, CT 06412, (860)526-2900. Referred to OSBI. OSBI is still working with the parties. Omarys Vasquez, State Building Inspector, reports that she is actively engaged with the Complainant. OSBI requested a copy of the inspection report from Mr. Leighton. As soon as the report is received, we should have an update for the Committee. OSBI/OSFM request all reports. We received inspection requests with handwritten notes that are not legible. OSBI will send copies to the Chair and the Committee will follow up in January 2023. OSBI reached out to the Building Official for more information – all files pertaining to said property. Referred to C&S Committee Chair, Vice Chair and Secretary. OSBI will send files and information received from the Appellant for panel to evaluate for proper procedure. Meeting scheduled: February 28, 2023 – 9: 00.m. The Chair recommends an informational Compliance Conference. The purpose of the conference is to see if they can collect more information to try and settle the issue at hand or determine if it should be referred to the State Police. Volunteers for the informational Compliance Panel: Glenn Neilson, Chair; Lou Free, Panel Member, Henry Miga; Panel Member; Tim Mikloiche; Alternate Member. **OSBI will prepare a findings summary for the Compliance Panel. Hold on agenda.**

Cofrancesco RE: [60 Pinehurse Drive, East Haven, CT – Elaine Cioffi (owner)]; Seeking revocation of East Haven Building Official’s License (James Bassett). Referred to OSBI for investigation. Hold on agenda until we can get a recommendation on processing from Counsel and Omarys. OSBI will continue to investigate. **OSBI received the supplemental report and will review it. Hold on agenda.**
- h) **A-13-22 RE:** Request for Appeal received 10/24/22 from Walter J. Onacewicz, Esquire, Nair & Levin, P.C. for James A. Balch. RE: [250 South Main Street, East Windsor, CT 06016] – State Building Code Section 117 Violation September 14, 2022, Notice of Imminent Danger, Order to Vacate and Posting of Unsafe Structure (“Order”) from Kenneth A. Rich, East Windsor Building Official. 11/4/22 Correspondence received from Brian L. McCann, Esq/Joshua A. Hawks-Ladds, Esq, Pullman & Comley, LLC - Town of East Windsor’s reply to “Notice of Appeal” filed by the Appellant, James A. Balch, dated October 24, 2022. Referred to OSBI for follow up. OSBI reached out to the Building Official. The appeal was filed to reserve their rights. Appellant obtained a permit, the B.O. flagged as an unsafe structure. Contract pulled permit and the building was demolished, renovations are ongoing. This issue appears to be resolved. Reached out to Attorney for a withdrawal of the appeal as they seemed to have worked out the issues. The Attorney feels that they will withdraw but holding on the agenda to protect their appeal rights. Omarys spoke with the attorney, and he says that the building official and the building owner have been collaborating and working together on the situation and correcting some of the non-compliant issues. They are sure that everything is copacetic. I asked them to make sure to let us know and to formally e-mail us that they are going to withdraw the appeal - at the time that they're ready. I would like to give him another month so I can reach out again and ask them if this is still open - Or at least it gives me a timeline on when they think it might end up getting resolved. OSBI reports the local Building Official and Appellant are still working on the issue. **The Chair requests a status letter be sent**

to the parties. OSBI will collaborate with Staff Counsel regarding a status letter. Hold on agenda.

- i) **A-14-22** RE: Request for Appeal received 11/14/22 from Robert Leety of Milford, CT RE: [830 W River Street, Milford, CT] RE: State Building Inspector's denial of Section R310.1 2015 IBC-Emergency escape and rescue opening required - to allow two basement bedrooms to have indirect access to an interior stair and an exterior door and the basement story to be protected with an NFPA 13D sprinkler system, instead of having emergency escape and rescue openings that open directly into a public way, or to a yard or court that opens to a public way. Panel assigned: Donald Harwood, Chair; Lou Free, Panel; Glenn Neilson, Panel; John Butkus. Hearing scheduled: January 11, 2023, at 9:00 a.m. Hearing suspended pending resolution with the Office of the State Building Inspector. Omarys will schedule a meeting with the IRC Sub-Committee to review the sprinkler exemption for the EERO windows. She will then schedule a meeting with the applicant to work on an alternative resolution. Correspondence received 2/22/23. OSBI met with the Appellant to find a mutual solution. OSBI will revise the modification letter as approved based on the mutual solution. **OSBI will reach out to the Appellant to request an official withdrawal.**
- j) **A-23-01** Request for Appeal received 1/10/23 from Kathleen Donovan RE: of Ned Dalton, CFEI-Naugatuck Fire Marshal - Abatement Order of Fire/Life Safety Hazards. RE: **[45 Woodland Street, Naugatuck, CT]** CSFSC & CFPC - CGS 29-291A and 293. CT Sec: 12.4.6.6.3.5.2(7); Door self-closing device are not operating properly. The self-closing device shall be operational so that the door fully closes from its fully open position. Referred to Office of State Fire Marshal for review. On 2/3/23 David Woods-OSFM Fire & Life Safety Supervisor submitted the Investigation Report. Panel Assigned: Keith Flood, Chair; Mike Sinsigalli, Panel; Glenn Neilson; Panel; William Zoeller; Alternate. Hearing scheduled: March 15, 2023 – 9:00 a.m. **Appellant withdrew opportunity to submit brief. Deliberations held. A motion to deny appeal (WZ), seconded (GN). All in favor – none opposed. Decision will be mailed out in 90 days (June 15, 2023). Hold on agenda.**
- k) **A-23-02** RE: Request for Appeal received 3/9/23 from Robert Kaye, Riverside Fence **[16 Boomer Road, Ridgefield]** OSBI denial of Section 305.2.5 closely spaced horizontal members - To allow an alternative barrier design comprised of 1"x6" horizontal members angled at 55 degrees from the horizontal, spaced at 11/8 inch and overlapping the horizontal member above/below by 2 ¾ inches from the pool side edge. Panel assigned: Glenn Neilson, Chair; Tim Mikloiche; Panel; Thomas DiBlasi; Panel; Donald Harwood; Alternate. The hearing is scheduled for April 5, 2023, at 8:30am. Hearing held. Deliberations followed. Both parties declined to submit briefs. A motion to deny appeal (TD), seconded (TM). All in favor – none opposed. **Decision will be mailed out in 90 days (July 5, 2023). Hold on agenda.**
- l) **C-23-01** RE: Complaint received 2/28/23 from Heide Mizak, RE: [69 Lohse Road, Willington, CT] James Rupert, Willington Building Official's "alleged" Work Ethics Violations (see attached email (2/14/23) and complaint letter to Willington Selectmen dated 11/22/22). Meeting scheduled February 28, 2023, with Chair, Vice Chair and Secretary. Referred to OSBI for further investigation. Hold on to the agenda until we gather more information. **OSBI will reach out to all parties prior to the next meeting. Hold on agenda.**
- m) **A-23-03** RE: Request for Appeal received 2/21/23 from Bruce Kramer, New Fairfield RE: [20 Cloverleaf Drive, New Fairfield] Abatement Order. The Town of Fairfield does not have an "appeals board". Appellant is asking the Committee to overturn the Notice of Violation and Order

to Abate because it creates an undue hardship and is procedurally defective. Per Chair, hold on agenda for further investigation. **OSBI to investigate and request more information.**

- n) **A-23-04** RE: Request for Appeal received 3/3/23 from Paul Payne, New Canaan Fire Marshal RE: [17 & 23 Hill Street, New Canaan] appeals/does not support the OSFM approval - Part II Section (3) 503.1.2 and 01.233 – “If agreeable to the owner/applicant & schedule allows. A site visit would be prudent”. OSFM approved modification. Local Fire Marshal requested an appeal of the State Fire Marshal’s decision. Counsel will look further into the jurisdiction of the appeal statute. **Counsel requested to hold on the agenda until the next meeting.**
