## 1. CAS MINUTES

a. A motion was made by Thomas DiBlasi and seconded by John Butkus to accept the draft meeting minutes of the January 10, 2024 CAS meeting. No discussions, all voted in favor, none opposed, motion is <u>APPROVED</u>.

## 2. COMMUNICATIONS

No correspondence was received since the last CAS meeting. State Building Inspector Omarys Vasquez confirmed that all CAS correspondence and code change proposals gets sent to the Codes and Standards Committee which then gets sorted by staff and directed to CAS.

## 3. OLD BUSINESS

- a. 2025 Connecticut State Building Code and Fire Safety Code Development
  - i) ICC 2024 Codes and ICC Premium Access Update. State Building Inspector Vasquez reported that Peter Zvingilas is looking into the status of obtaining ICC Premium Access for CAS members.
  - ii) DAS DRC CAS SharePoint Drive. Under "Documents > 2025 Code Development > 20\_References" are redline versions of the 2024 IBC, 2024 IEBC and the 2023 Draft for ICC Standard A117.1 Accessible and Usable Buildings and Facilities. State Building Inspector Vasquez reported that the redline versions of the 2024 IFC, 2024 IMC and 2024 IPC will be uploaded to the CAS SharePoint Drive after this meeting.
  - iii) 2024 IRC Availability Update: Chair Free requested William Nash, Senior Regional Manager, International Code Council, to provide an update on the status of the expected availability of the 2024 IRC. Mr. Nash reported that the hearings for nine (9) appeals related to the 2024 IECC have been scheduled for February 21, 22 and 23. After the appeal hearings there is an anticipated 30-day process which is the end of March. Assuming there are no further challenges, we appear to be on track for the 2024 IRC and 2024 IECC being published and available in the middle of this year.

State Building Inspector Vasquez asked if the red line version of the 2024 IRC minus Chapter 11, which is tied to the energy portion of the 2024 IECC appeals, is available for the Work Group to review. Mr. Nash stated many states are going through the same exercise and asking the same question, so there will be a version of the 2024 IRC draft put into the digital code platform without Chapter 11 in the near future for states to review.

Johnny Carrier asked on the status of the publication for the significant changes handbook that usually goes with the new codes. Mr. Nash responded that work on producing the 2024 Significant Changes to the 2024 ICC Codes is in process and will notify the CAS when they are published and available.

- iv) Work Group Assignments. Chair Free reported that many of the past Constituency representatives who assisted the Work Groups with the code review are no longer employed by the group they represented. State Building Inspector Vasquez stated she is currently coordinating with Darren Hobbs and has reached out to former State Building Inspector Joseph Cassidy for additional information.
