Mr. Dillon reported that the proposal is for the New Britain-Hartford Busway, a 9.4 mile corridor planned along the rail corridor linking downtown New Britain with Hartford's Union Station. DOT has 120 acquisitions (partial and total takings) planned. The subject site is located at 17 Bartholomew Avenue in Hartford. The subject property is encompasses approximately 1.15-acres and is currently improved with asphalt pavement and is utilized as a parking lot.

Mr. Dillon said that DOT will acquire an easement for transportation purposes totaling 1,395 SF (0.033-acres). The subject area for this transaction is located along the site's western boundary adjacent to land of Amtrak. The appraiser has determined that the takings have a minimal impact on the site as it will only require a minor reconfiguration of parking spaces and improvements to an existing retaining wall.

DOT Appraiser Mark Mickiewicz did a before and after valuation and identified comparable sales between \$1.04/SF and \$6.92/SF. DOT then identified an overall value of \$3.50/SF and determined the value of the easement based on the direct damage approach to be \$6,700.

Mr. Dillon recommended approval because the acquisition complies with Section 13a-73(c) of the CGS which governs the acquisition of property by the commissioner of transportation required for highway purposes; and the acquisition value is supported by the appraisal prepared by DOT.

**PRB FILE** #10-335 – Mr. Norman moved and Mr. Pepe seconded a motion to return PRB File #10-335 to the Department of Public Works because the Litchfield County Jail is a surplus property under Section 4b-21-(c), and as such the proposed license agreement requires the prior approval of the Office of Policy and Management; and since the State currently leases 5,825 sq. ft. on West Street, Litchfield at an annual base rental cost for these leases is \$114,987.96, the Board recommends that the client agencies and DPW evaluate the Litchfield County Jail for occupancy. The motion passed unanimously.
