Mr. Dillon reported that this is the 6th series of On-Call Structural Engineering Consulting Contracts awarded by the Department of Construction Services ("DCS") since 2002. The four On-Call Contracts that are the subject of

this memorandum have a maximum total cumulative fee of \$500,000 per contract and a common expiration date of 02/14/2014.

DCS has made some minor revisions to the boilerplate contract for this series to include state's rights for inspections, state ethics law, updated executive orders, new non-discrimination language and sovereign immunity language. All of the four selected firms under this current 6th series RFP have been previously approved for Structural Engineering On-Call Contracts. DiBlasi Associates was awarded a contract under the 3rd Series, Macchi Engineers was awarded contracts on the 2nd through 5th series, GNCB was awarded contracts on the 1st, 3rd and 5th series and James Purcell Associates was awarded contracts on the 2nd and 4th series. A Request for Qualifications for the consultant services was released in June 2011 and elicited 20 responses. All of the respondents were considered "responsive". Thereafter, the DCS selection panel began the process of evaluating all 20 proposals. The State Selection Panel consisted of 5 members and rated each firm based upon a weighted ranking system.

Mr. Dillon recommended approval of the above referenced four firms as potential structural engineering consultants for projects of various sizes and scope. All four consultants provided the required insurance, Gift/Campaign and Consulting Affidavits accompanied by appropriate Corporate Resolutions.
