Mr. Dillon reported that PRB #12-060 and #12-061 concern releases of land acquired in Putnam and Killingly in connection with the reconstruction of Tracy Road and Park Road. The project is complete and it now necessary for the State to assign the land to the Towns per Agreement No. 04.29-09(96) dated 10/15/1996. The project release area in Killingly comprises 11,179 SF of land SF which was part of the initial 58,728 SF acquired by the State for the project. The project release area in Putnam comprises 2,353 SF of land SF which was part of the initial 3,053 SF acquired by the State for the project. The original area acquired by the State through condemnation encompassed four contiguous parcels all under the ownership of the same individual. The project is complete and this is a release along a town street for highway purposes only and there is no monetary consideration.

Ms. Goodhouse reported that the New Britain-Hartford Busway is a 9.4 mile corridor planned along the rail corridor linking downtown New Britain with Hartford's Union Station. DOT has 120 acquisitions (partial and total takings) planned.

The subject site is located at 17 Bartholomew Avenue in Hartford and the subject property encompasses 1.15 acres \pm improved with asphalt paving; it is a 104-space parking lot. In a previous taking from this parcel, DOT acquired a 1,395 SF easement for transportation purposes along the AMTRAK boundary (PRB File #10-336). Compensation was paid at the rate of \$3.50/sf as follows:

This agenda item concerns an additional easement for transportation purposes of 569.20 SF along the westerly boundary will be acquired. This taking will interfere with existing layout of the parking spaces. With rearranging and restriping, the lost spaces can be re-located on the premises. The damage award to re-design and re-stripe a portion of the lot was based on an estimate prepared by Baker Engineering.

On the adjacent property to the south, which is owned by Bartholomew Capital, LLC, the Grantor has a right of way as shown on the sketch provided. The right of way bisects the property and then runs along the Amtrak right of way to the Grantor's property line. DOT will acquire (extinguish this right of way).

As before, an appraisal prepared by Mark J. Mickiewicz valued the site at \$3.50/SF. As compensation for the extinguished right of way over the adjacent property, a lump sum of \$7,000 was estimated based on an estimated area scaled from the taking map and calculated based on the land value (\$3.50/sf). The table summarizes the damages.

Ms. Goodhouse recommended approval of the item. The acquisition complies with Section 13a-73(c) of the CGS which governs the acquisition of property by the commissioner of transportation required for highway purposes. The acquisition value is supported by the appraisal report prepared by DOT.
