This is the 5th series of On-Call Claims Auditor Consulting Contracts awarded by the Department of Construction Services ("DCS") since 2002. The On-Call Contracts that are the subject of this memorandum has a maximum total cumulative fee of \$300,000 per contract and a common expiration date of 06/30/2014. This is the third submittal under this contract; the Board has previously reviewed the firms of Blum, Shapiro & Company, P.C. and Navigant Consulting Inc under PRB Files #12-107 and #12-108 respectively.

Hill International, Inc.(HII) originally established in 1975 and is locally located with an office in Marlton, New Jersey. HII has a staff of 3,000± employees on an international basis including 185 within its New Jersey Office. This office branch has 40+ Architects/ Engineers and 2 claim review specialists. The company has not been awarded an on-call contract or formal contract over the past two years. HII scored a total of 451 out of a possible 500 points and was identified as one of the most qualified firms.

Mr. Dillon recommended Board approval of the firm as referenced above as an Auditor for various projects. HII has provided the required insurance, Gift/Campaign and Consulting Affidavits accompanied by appropriate Corporate Resolutions.

administration services due to the extension of the project schedule.

Mr. Dillon reported that the project involves the design and construction administration services necessary to remove the existing undersized sprinkler piping, heads, valves, etc. and replace the above with a new system that will be connected to the existing fire alarm system. The design of the fire suppression renovations for Buildings 3 and 4 will be in accordance with National Fire Protection Association (N.F.P.A.) 13 requirements.

The work will involve replacing the existing fire sprinkler system (remove the existing undersized sprinkler piping, heads, valves, etc.) and replace the above with a new system including but not limited to sprinkler piping, flow switches, heads, and valves, and connecting the new sprinkler system into the existing fire alarm system. The design will include the basement, 1st and 2nd floors and the design of draft stops in the attic spaces.

Construction and total project budgets were initially established at \$1,800,000 and \$2,350,000. Construction and total project budgets have since been revised to \$1,329,700 and \$1,730,200 to reflect the elimination of Building #2 from the project scope. As with the preceding task letters concerning the Veterans facilities, the cost of design and construction is allocated between the State (35%) and Federal government (65%). An \$8.0 million federal grant covers the latter's share of costs.

In 2008 BL Companies Connecticut Inc. ("BLCC") was awarded a contract to provide MEP services on various DCS projects through approval of its "On-Call" contract for a not-to-exceed amount of \$500,000.

TASK LETTER #6B will modify the contract for BLCC as follows:

- The firm's total fee increases under Contract OC-DPW-MEP-0020 by \$9,000 from \$95,500 to \$104,500 for Project #BI-C-277; DVA Buildings #3 & #4 Fire Suppression and Renovation.
- This additional scope and compensation is being requested due to the fact that DCS has extended the overall project construction schedule six weeks due to project weather delays and schedule issues.

Mr. Dillon recommended approval of the task letter.
