Project Purpose: DOT Conveyance of Drainage Right of Way

Item Purpose: Conveyance of approximately 625± SF of drainage right of way to the

Grantee for the purposes of constructing drainage improvements required after the completion of the *Reconstruction of Prindle Road*

Project.

Staff reported that in 2012, the Department of Transportation ("DOT") was contacted by the City of West Haven related to ongoing flooding at 46 Prindle Road. The city expressed concerns that the *Reconstruction of Prindle Road Project* had created an adverse drainage condition on this property which was causing subsequent flooding. The City agreed to install additional drainage improvements on the property to alleviate the issue. As such the City requested that DOT convey to the City a *drainage right of way* ("DROW") for the purposes of constructing the improvements.

Based on survey plans provided by DOT, the State will convey to the City of West Haven a 625 +/- SF DROW. The proposed DROW will be comprised of an 84 +/- LF easement with a 4-inch pipe underdrain system. After reviewing the information, DOT conducted an internal evaluation of the DROW and concluded that it should be conveyed to the City without consideration since it will relieve a potential liability created by the State during the *Reconstruction of Prindle Road Project*.

The DROW is being provided to the City as a municipal road release and is being conveyed at this time to allow the drainage improvements to be constructed in timely manner. The transfer of any other remaining right-of-ways and easements associated with the *Reconstruction of Prindle Road Project* will be transferred at a later date. This transfer is consistent with the terms of FHWA Agreement No. 11.13-06(97). Staff recommended approval of this submittal.

Grantee: Greenwich Historical Society, Inc.

Property: Located along the northwesterly side of Strickland Road, Greenwich

Project Purpose: DOT Mutual Release and Grant of Restrictions

Item Purpose: Conveyance of approximately 0.44-acres of land to the Grantee pursuant

to Public Act 12-2 Section 147. The Grantee is required to use the parcel

of land for purposes consistent with the mission of the Greenwich Historical Society.

Staff reported that this conveyance was originally enacted by SA 08-8 and approved by the Board under PRB File #08-295. This conveyance includes approximately 0.44-acres of vacant land and is located along the northwesterly side of Strickland Road in the Town of Greenwich.

In 2008, the property was inserted into SA 08-8 Section 1 as a legislative conveyance to the Historical Society of the Town of Greenwich. The conditions of the conveyance were that the property be used as parking. In addition the deed contained a reversion clause should the property not be used for the purposes outlined in the conveyance.

In 2012 PA 12-2 Section 147 amended this approval and provided for a mutual release and grant of restrictions whereas, the Grantee is now known as the Greenwich Historical Society Inc. and that the "Historical Society of the Town of Greenwich shall use the property for purposes consistent with the mission of the Greenwich Historical Society. If the Greenwich Historical Society does not use said parcel for said purposes, does not retain ownership of all of said parcel; or leases all or any parts of the property it shall revert back to the State.

The legislative language requires the property to be conveyed for an administrative fee which DOT has determined to be \$1,000 for this transaction. SPRB staff recommended approval of this item.

Mr. Josephy moved and Mr. Norman seconded a motion to go out of Open Session and into Executive Session. The motion passed unanimously.
