Staff reported that this is the 1st series of On-Call MBE Engineering Consulting Service Contracts awarded by the Department of Construction Services ("DCS"). The Board previously approved the first three contracts under this series (PRB#14-105 – #14-107) and as such this submittal is for the final three firms identified in the initial transmittal for this series.

A Request for Qualifications (RFQ) for the consultant services was released in July 2013 and elicited eight (8) responses. All of the respondents were considered "responsive" and as such all of the submittals were considered for review. Thereafter, the DCS selection panel began the process of evaluating and short-listing six proposals. The State Selection Panel consisted of three members and rated each firm based upon a weighted ranking system.

At the completion of the State Selection Panel process, DCS Management Team reviewed the results and recommended the approval of six firms under this series. At this time, DCS has submitted the following three firms to SPRB for review and approval:
