BACKGROUND: The Department of Transportation (Project #143-192) is in the process of designing and building a new Bridge facility and Signs & Marking facility and two storage buildings (cold and warm) at 80 Fowler Avenue in Torrington, CT. The purpose of Project is to replace a functionally obsolete and non-compliant facility with two new facilities that will be in compliance with the applicable portion of

the "Major Capital Program Design Manual" and existing agreements between the DOT and DEEP. Site work includes grading, utilities replacement, demolition of existing facility, demolition of two storage buildings, and corresponding site improvements.

Under this Proposal (PRB #22-181) DOT has submitted to SPRB for approval of this Gas Distribution Easement granting an easement covering approximately 6,663 square of land in Torrington over land utilized by DOT, to connect the site to natural gas as part of the Project.


The Grantee has agreed to supply gas to the site but requires an easement agreement to install all the required infrastructure and meters for gas service to be provided to the premises.
