The Board noted the following:

- 1. DAS did not comply with CGS 4b-34 in that LP 21-06 required interested parties to respond in 12 days which appears in violation of the statute. This statute requires a minimum 15-day period prior to final selection of a Proponent; and
- 2. In light of DAS' recently changed position that SPRB review and approval/disapproval of Renewal Options is no longer required, the SPRB cannot consider approving any Lease containing Renewal Options. Per CGS 4b-3(f), prudence dictates that any renewal of a Lease beyond 5 years be independently reviewed to ensure future renewal rates are commensurate with future market conditions, as well with compliance with state statutes, DAS policies and procedures and lease requirements.
