Project Background:

On January 12, 2007, the AG approved a new Lease between the State of Connecticut and Norwalk River Wood Products, LLC for a five-year term ending January 31, 2011. The initial rent was \$1,250/month. There were two five-year options to extend the Lease subject to a review and update of the monthly rental fee. DOT leased the land pursuant to their authority provided in CGS 13a-80a. The land area was approximately 40,000 square feet and its use was limited to light saw mill work. The lease specifically excluded utilizing 5,625 square feet of land in Ridgefield for light saw mill work.

Under this proposal (PRB #23-102), DOT is seeking SPRB approval to enter a Lease with the Norwalk River Wood Products, LLC for a 5-year term, with two, 5-year options to extend the term. This new Lease will encumber 3.67 acres. DOT authority to enter this Lease is pursuant to CGS 13a-80.

The terms of the lease are as follows:



The Lessee executed the Lease on May 4, 2023. The Lessor executed the Lease on May 11, 2023. OPM approved the Lease agreement on June 20, 2023.

RECOMMENDATION: Board approval of the Lease (lease-out) agreement to Norwalk River Wood Products, LLC is recommended for the following reasons:

• The commissioner of transportation has the authority under CGS §13a-80 to enter into lease agreements, subject to the approval of OPM (received 6/20/2023), the SPRB & the AG.

- This covers 3.67 acres of land to be used for the purpose of temporary structures, storage of materials and equipment used in conjunction with light saw mill operations and an excavating and landscaping business.
- The Lessee initially pays \$3,500/month, increasing annually by 2.5%. The State reserves the right to terminate the lease with 30 days' notice.
