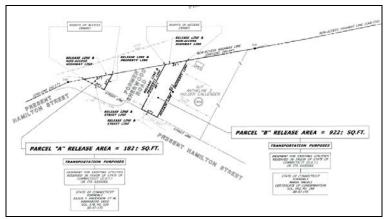
Item Purpose: Quit Claim Deed

Under this Proposal (PRB #23-225) DOT seeks Board approval of this Quit Claim Deed conveying three parcels of land containing approximately 2,824 square feet of land and easements to the City of New Britain.

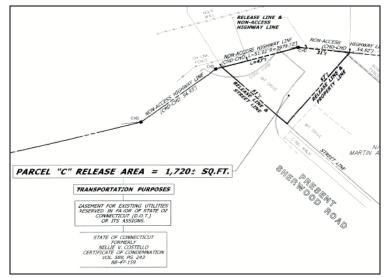
DOT provided this narrative in support of the Release:

Attached are a deed and a release map for the proposed release of three parcels of State land consisting of 2,824± square feet, more or less, which will be released to the City of New Britain (City) for transportation purposes pursuant to a Town road Release.

These parcels of land were acquired by the Department of Transportation in 1965 as part of project 0088-0047, the relocation of Route 72. The subject parcels are outside the Route 72 highway line, are adjacent to, and are effectively needed for the function of the New Britain Town Roads Hamilton Street and Sherwood Road. Project 0088-0047 was completed and the subject parcels will be incorporated into the City's roadway inventory and will be partially developed as part of New Britain's multi-modal Beeline Trail project.
