4. System Updates

- a. Annual Calendar
 - New request anticipated via United Way of Greater New Haven, to link homelessness records with employment and wage records (CCEH and DOL data match). Request form expected soon, no fixed deadline.
 - New request anticipated for <u>transfer guarantee programs</u> between community and independent colleges (CSCU and CCIC), via New England Board of Higher Education (NEBHE). Anticipate data match in November / December, no fixed deadline for final report. OPM will reach out to CCIC to set up meeting with NEBHE, CSCU.
 - Agreements for pre-K impact study to be circulated soon.
- b. Brief recap of Executive Board meeting, successful meeting with engaged leadership. All signatures on EMOU have been collected final agreements to be posted next week.
- c. Proposals requested for SLDS annual conference by next Friday, September 3. Survey link to be sent via email.
