There are currently 34 states on the list of "hotspots' as the COVID transmission rates for those locations has reached the threshold for concern: https://portal.ct.gov/Coronavirus/travel While there is no current travel ban, Governor Lamont has put a protocol into effect requiring quarantining upon return travelers entering Connecticut **from** these locations. This and other provisions also assist with contact tracing. DCF's Bureau of Child Welfare leadership is authorized to make short trip, out of state travel decisions.

As for our students enrolled colleges in these identified "hot spot" states, we must take a more measured approach. Given the statutory authority for these young people, I am obligated to make decisions on their behalf. Therefore, I will be reinforcing the difficult decision to deny on-campus residence at any of the out of state schools in "hot spot" states for youth committed to the department's care. Our students should be prepared and heavily supported for on-line coursework for the Fall 2020 semester or until further notice.



Whether it's considerations for college students or making decisions to support K-12 education, planning during a pandemic is challenging.

Our Education Division and Child Welfare Bureau have convened internal discussions on topics related to Back-to-School planning. This includes working with CT State Department of Education leadership. As CSDE guides districts across the state on their individual strategies, we have been sharing considerations for educators as they plan for the children we mutually serve.

Lastly, we continue to review the data, listen to our workforce and partners on the impact of our pandemic response to date. We keep in mind that amid a public health emergency, stakeholders have varying perspectives. For example, questions have been raised about the cohorts of children included in the in-person visitation triage processes. Feedback from our facilities as well as our area offices, help us actively plan to introduce additional cohorts of children for consideration. As it stands, the public health metrics and a myriad of other factors guide proposed next phases targeted for the week of 8/15/20 with planning for the remaining children in our care potentially being included in this triage process by the end of the month provided transmission rates hold steady.

Our Resuming Full Functioning Plan is fluid yet deliberate. It includes recommendations from inside and external to the dept. There are many moving parts to balancing the safety of our workforce with the mission critical work of DCF. Critical thinking guides every cautious step we take TOGETHER.
