- A focus on *characteristics* to ensure a holistic approach to recommendations moving forward.
- Characteristics are identified based on prior workgroup discussion and grouped to structure additional dialogue:
  - Access: Characteristics related to how accessible the entity is to families and other referral sources
  - Experience for the families: Characteristics about the experience and level of support that families should have when in contact with this entity
  - Workforce Capabilities: Characteristics related to the abilities and approaches of the workforce in contact with families
  - Structure/organization of entity: Characteristics about the way the entity is structured/organized in relation to other providers, communities and the families
  - Infrastructure: Characteristics about the organizational and resource capacities of the entity to fulfill its functions
  - Others?

#### Access

- Easily accessible for the families
- Website and phone line open 24/7

#### Experience for the families

- Provides a 'safe' and stigma free environment
- Provides a clear plan to the family for next steps
- Maintains some relationship with family throughout service delivery
- Supportive and empathetic to the families' situation

#### Workforce capabilities


- Social work credentials
- Paraprofessionals/peers

#### Structure/ organization of entity

- Local connection and knowledge about community
- Formalized partnerships and collaboration with relevant stakeholders, providers

#### Infrastructure

- Clear structure for referrals from/to other providers
- IT infrastructure that aligns with the documentation needs



## Concepts related to Eligible Families for Family First



### Operational Requirements related to Eligible Families for Family First

	Summary of Family First Requirements	Connecticut's Approach
Eligible Populations are Defined	"Imminent risk of entering foster care" and pregnant and parenting youth in foster care	Completed: identification of candidacy groups
Eligibility is Determined	The <u>title IV-E agency</u> must determine eligibility of the child	Key question - How will DCF work with a care entity to operationalize these requirements so that the experience is consistent with prevention work and is seamless to the family?
Service Planning	A child-specific prevention plan for candidates or case plan for pregnant and parenting youth must be in place prior to receipt of services	
Service Receipt	Service can be received for up to 12 months initially; redeterminations of candidacy allow additional/contiguous 12-month periods	
Ongoing Monitoring	Oversee safety of children receiving services and conduct periodic risk assessments to inform the child-specific prevention plan	
Data Collection	Data reports must include demographics of the child, prevention plan dates, service start/end dates, service expenditures and foster care entry status/dates (if applicable)
