2025 FOSTER CARE MAINTENANCE
PAYMENT REPORT
SPECIAL ACT NO. 25-6

Background

Foster parents are essential to the child welfare system. Children who cannot remain safely in their parental home, must have a place to reside while efforts toward reunification or another permanency plan are completed. The Department of Children and Families (DCF) has continued to provide resources and support to staff responsible for recruiting and supporting foster families, but there continue to be challenges related to recruitment and retention of foster families.

A national placement crisis currently exists across the country, including Connecticut. Foster families are experiencing increased challenges given the higher acuity of need for children coming into DCF care. The DCF Caregiver Advisory Group has developed strategies for recruitment and the data in this report could provide some important insight for policy makers.

Special Act 25-6 "AN ACT CONCERNING FOSTER CARE MAINTENANCE PAYMENTS" requires the Department to submit a report that includes information concerning foster care maintenance payments provided by DCF to foster parents in the state. While considering the data in this report, keep in mind that a 5% increase was provided to foster care rates in 2024 to attract more families to support our children.

Rates and Schedule of Payments in CT

Payments to Foster Care/Kinship Care families are typically made monthly.

Comparison of Neighboring Jurisdictions

The model and structure of foster care maintenance payments of our neighboring states (MA, NY and RI) are somewhat comparable to CT and each other, but with some slightly different nuances that do not make them directly comparable.

Some examples of key differences include, but are not limited to:

- The age groups for payment structures being different in RI
- MA does not provide higher payment levels for children with different medical complexities like other states (including CT).

Massachusetts

Daily Rate – Foster parents receive a reimbursement for providing care at the daily rates the Department establishes. The current daily rate is below, and payments are provided twice a month (24 times per year).

- Ages 0-5: \$33.27
- Ages 6-12: \$37.71
- Ages 13+: \$39.40

Clothing Allowance – Foster parents receive a clothing allowance for foster children in their care at the rates below. This payment is provided on a quarterly basis.

- Ages 0-5: \$330.44
- Ages 6-12: \$340.82
- Ages 13+: \$410.02

Foster parents also receive \$100 to help pay for a birthday gift and \$200 for holiday gifts for each foster child each year.

Rhode Island

The foster board maintenance payment for children and youth who enter foster care on or after August 1, 2020, is determined by their tier score identified by their Level of Need (LON) assessment. (See chart below for rates.) A child with the highest needs is Tier Score 5 and a child with the lowest needs is a Tier Score 1.

Most children and youth who are placed with foster families score at 1, 2 or 3. The goal of the LON assessment is to clearly identify each child's needs, what type of home would be the best fit for their needs, and what services might be needed for that child. The LON assessment tool is the cornerstone of the foster care system.
