- Al Johnson retired, his position is being filled by Lisa Zuccaro former ACR PM
- Eric Burnell former New Britain SWS will be the new ACR PM

DCF Performance data-handout given

- The number of children in care has declined-one of DCF's goals
- Relative & Special Study is something we are working to increase
- Congregate Care-the goal is to decrease
- Decrease in the number of entries into care is because of the Considered Removal process
- Children served in their homes-are these children's needs being met?
- Report that measures the In-Home Cases-% of high risk, % that need legal involvement and % of low risk that are ready to be closed
- Does DCF have the number of all children served not just the CIP children?
- 0-3 children-In Home –is increasing
- DCF has asked for a report to capture this information-right now the data is not available
- Going forward RAC could have a data agenda
- We never see the population that DCF prevents form coming into care
- Systems of prevention, FAR and voluntary services
- 4 Regions of Systems of Care could get this information
- Where are the CIP children going? Foster Care, Relative Care, Special Study or Congregate Care
- Great job by DCF-Region 4 leads in low number of children coming into care
- OPPLA=children other than TOG, Reunification or Adoption
- OPPLA-legal permanency
- Region 4 20.9% =Foster Care and 79.1% are TOG, Reunification and adoptions
- Regions doing well should share their practice-this is happening
- DCF is meeting on Permanency practices
- There is a gray area-children not being adopted but there is a strong connection
- The 20.9 % with OPPLA goal is the population we are focusing on
- Open adoptions are an option
- Kinship care-is there an increase in support for Kinship care?
- Caregivers support-CHR has the contract for this
- Disproportionality data in the handout
- DCF can bring more data to the meetings-more to come
