Preliminary Status Report Concerning the Use of Deadly Force In Waterbury, Connecticut on January 20, 2020

Pursuant to Public Act 19-90, the Division of Criminal Justice submits this preliminary status report regarding the use of deadly force in Waterbury, CT on January 20, 2020.

Edward Gendron, a 57 year old Caucasian male died as a result of gunshot wounds sustained during an encounter with Waterbury Police Officer Ronald Tompkins. Mr. Gendron's injuries were sustained on January 20 at approximately 12:26 p.m. in his home located at 81 Craigie Avenue, Waterbury. The Waterbury Police Department is the only agency implicated in the use of force. No toxicology report is available as of the date of this report and the ME-123 is attached hereto.

On January 20, 2020, the undersigned was appointed to lead the investigation to determine whether the use of force was appropriate under General Statutes Section 53a-22. Assistance is being provided by the Connecticut State Police Central District Major Crime Squad who processed the scene and are conducting interviews of potential witnesses.

I wish to extend my condolences to Mr. Gendron's family and will provide further updates when warranted.
