


The Danbury Judicial District

The Danbury Judicial District (JD) serves eight towns in the western part of the state. Included in the District is a single Geographic Area (GA) court, GA 3 in Danbury. The District is bordered on its west by New York State. The JD also contains a high-security state prison, Garner Correctional Institution, in Newtown.



Approximately 200,000 people live in the Danbury JD. Danbury, the largest town in the District, is home to about 42% of District residents; it is also home to approximately three-quarters of the JD's minority residents.

When measured against the per capita income of the state, all towns in the Danbury JD, with the exception of Danbury proper, are more affluent than the statewide average.



Each year, the FBI releases Uniform Crime Report data (UCR) which details the number of major crimes reported to state and local jurisdictions during the previous calendar year. In this data, murders, robberies, aggravated assaults and rape are grouped as violent crimes. Property crimes are larcenies, burglaries and motor vehicle theft.

The incidence of crime in the Danbury Judicial District varies significantly across the eight-town area. While the city of Danbury is home to only about 42% of the JD's population, it accounted for 85% of the District's violent crime and 65% of its property crime 2018.

According to CT Judicial Branch data, police agencies made 2,500 criminal arrests in 2018. In addition, they made about 2,300 motor vehicle arrests. The lower totals for 2020 reflect the impact of the Covid pandemic.

In terms of the volume of criminal arrests, the Danbury Police Department is the most active law enforcement agency in the District. In 2020, the Danbury Police Department made 55% of all criminal arrests and 33% of all motor vehicle arrests, district-wide.

Compared to judicial districts around the state, the Danbury JD was the 9th largest in terms of population and the 10th busiest in criminal arrests.

or after paying a bond. Typically fewer than 25% of people are unable to meet these release conditions. As a result they are held in Judicial Branch lockups until they can be arraigned before a judge. At arraignment, judges may impose new release conditions.

a typical year. More serious cases are generally transferred to the Part A court at the Judicial District.

In recent years, between 300 and 400 case have been deemed serious enough to warrant transfer to the District Part A court.

Although the Part A court in Danbury handles over several hundred cases a year, only a small fraction of these cases are disposed at trial. Statewide, only about 4% Part A cases are disposed at trial.

Although even low levels of crime are unacceptable, the towns in the Danbury JD are fortunate to much have lower crime rates than the state average. With this in mind, it is notable that one of the most notorious crimes in recent memory, the Sandy Hook elementary school massacre occurred in Newtown in 2012.
