Legal Matters

Case Number: 2022-984 Walgreens #06914; PCY.0001943

Attorney Michael Ando presented this case.

Summary: Respondent is a Connecticut Pharmacy investigated following a complaint of unscheduled closures.

Respondent pharmacy is alleged to have closed the prescription department more than one calendar day for any such unscheduled closure, and to have had more than two unscheduled closures in a 30 day period. Such closures were appropriately reported to the Commission, and each was a partial closure.

Proposed Resolution:

Counsel for Drug Control proposes a settlement in which Respondent shall pay a voluntary monetary payment amount of \$1,500, which has been paid.

Commission Action: Commissioner Carbray moved, seconded by Commissioner Linder and passed by a vote of 5-0 to accept and approve the aforementioned settlement agreement.

Case Number: 2022-1802 Walgreens #10310; PCY.0002120

Attorney Michael Ando presented this case.

Summary: Respondent is a Connecticut Pharmacy subject to a routine pharmacy inspection. Respondent is alleged to have had deficiencies including failure to maintain an orderly pharmacy area, failure to appropriately maintain prescription records and perpetual inventory of scheduled controlled substances, failure to have a current registration and training documentation for all pharmacy technicians, to have outdated non-prescription drug stock, to have had unscheduled pharmacy closures without appropriate notification to the Commission of Pharmacy, and failures related to the reporting and quality assurance monitoring of prescription errors. Voluntary corrective measures were undertaken by the Respondent during and following the inspection.

Proposed Resolution:

Counsel for Drug Control proposes a settlement in which Respondent agrees to appropriately reconcile and maintain records of prescriptions as required by law, appropriately inventory controlled substances and maintain records in an order state, ensure out of date or adulterated drugs are removed from stock, ensure all staff have current licensing, training documentation, and identification, and maintain pharmacy premises in a clean and orderly fashion. Additionally Respondent shall pay a voluntary monetary payment amount of \$10,000, which has been paid.

Commission Action: Commissioner Carbray moved, seconded by Commissioner Linder and passed by a vote of 5-0 to accept and approve the aforementioned settlement agreement.

Summary: Respondent is a Connecticut Pharmacy which was investigated following a patient dispensing error complaint. Respondent is alleged to have failed to indicate in records the name of the pharmacist who dispensed or refilled a drug, rendering the audit trail incomplete.

Proposed Resolution:

Counsel for Drug Control proposes a settlement in which Respondent shall be issued a Letter of Reprimand and pay a voluntary monetary payment amount of \$500, which has been paid.

Summary: Respondent is a Connecticut Pharmacy which was investigated based on evidence gathered in a distinct investigation. Respondent is alleged to have failed to indicate in records the name of the pharmacist who dispensed or refilled a drug, rendering the audit trail incomplete.

Counsel for Drug Control proposes a settlement in which Respondent shall be issued a Letter of Reprimand and shall pay a voluntary settlement payment in the amount of \$500, which has been paid.
