OLD BUSINESS:

1. Legislative Proposals

A. Raised Bill 250 - An Act Concerning Flat Glass Occupational Licensing

At the February 27, 2020 meeting, the Board noted that they were in favor of this bill.

B. Raised Bill No. 5294 – An Act Concerning Auto Glass Emergency Temporary Technicians

At the February 27, 2020 meeting, John Wisniewski and Ed Fusco stated that they were opposed to this bill and it was determined that John Wisniewski will contact the lobbyist and Leslie O'Brien on behalf of the Board.

2. Continued discussion concerning replacement references for the AG-1 and AG-2 license types.

3. PSI Exam Review Committee Workshop for FG-1, FG-2 – May 20 and 21, 2020

This workshop was cancelled. A new workshop may be scheduled in September. Currently there are several SMEs writing items for FG-1 and FG-2, including Jennifer Russell-Vanasse and Jessica Olander.

PSI has done an analysis of the item pools for AG-1 and AG-2 and have been able to cross reference quite a few items to AGRSS or ROLAGS or to other technical information that is promulgated by AGSC and likely can be considered trade knowledge. PSI will work with John Wisniewski on this analysis.
